# Conference Checklist

Please consult your administrators for any school district- or school-specific procedures.

Follow essential dates and deadlines outlined in the Call to Conference.
Set up a money collection with your school's bookkeeper.
Set chapter deadlines for registration and payment.
Send permission slips with conference information, including cost and code of conduct, to members
and parents.
Collect member payment before the registration deadline.
Register all members, advisors, and support staff by the registration deadline.
Print the emailed invoice and double-check it for accuracy, then triple-check it.
Submit an invoice to your school's bookkeeper for payment.
Mail a check or submit a credit card payment to North Carolina TSA by the payment deadline.
Review the tentative agenda with attending members.
Host a chapter meeting with students to discuss expectations and responsibilities.
Host a chapter meeting with parents to discuss expectations and responsibilities.
Establish an online testing time for those taking the test on February 13.
Remind students to upload their preliminary submissions.
Ensure each attendee has signed a multiple-release form, which is kept with the chapter advisor.
Have all members follow and like North Carolina TSA on social media sites.
Discuss Regional Conference expectations with members so they are prepared.

# **Best Practices from Experienced Advisors**

Please confer with your administrators before putting any of these into practice to ensure compliance with school district and school policies:

- Have a parent meeting before the conference to lay out expectations and consequences.
- Create a behavioral contract for members and parents to sign.
- Collect parent phone numbers and emergency contacts just in case.
- Collect a deposit from those who commit to attend, primarily if members are fundraising.
- Think quality over quantity—3 competitive events per student is an excellent sweet spot.
- Ensure students have a mix of event types, including team and individual competitions, as well as early and on-site events.
- Help students determine their schedules so they feel prepared.
- Determine your advisor schedule and communicate it to attendees.
- Set up a group chat (e.g., GroupMe or Remind) with all attendees to facilitate quick communication.
- Hold a chapter meeting to check in with students and provide updates.
- Ensure that student submissions meet the quality standards expected by your school.
- Set clear behavioral expectations in advance.
- Ensure that students can access an advisor at all times.

- The Western Region Conference serves all LEAs west of Forsyth County, including Forsyth County itself.
- The Central Region serves all LEAs between Guilford and Wake County. Central Region Chapters can attend either the Western or Eastern Region Conferences.

#### **ELIGIBILITY**

Affiliated chapters and members can register for competitive events at the Regional Conference. Chapters considering affiliation with NCTSA may also register to compete in these conferences. ALL ATTENDEES, including members, advisors, and support staff actively participating in conference activities, are REQUIRED to register.

# INFORMATION NEEDED TO REGISTER

- Username and Password = National TSA Affiliation Username (Chapter ID #) and Password
- Judges System Student Password = NCtsa2026
  - You will set this yourself, and it will be the same for every student in your chapter.
  - Students can log in to the judge's system and upload their projects.
- Competitive Event Selections for Student Participants and their email addresses
  - MAX 6 EVENTS PER MEMBER (Nationals). Chapters are encouraged to have students compete in only THREE events. All work must be completed during the current school year.
  - Please note: You must select a Team Captain for team events. The Team Captain will be the student designated to upload the team's materials to the judges' system.

# **EVENT CHANGES AND SUBSTITUTIONS**

You can change your registration as often as possible until registration closes on JANUARY 21 at 11:59 PM. Simply log back on, edit, and resubmit. Beginning JANUARY 22, you will need to contact the <a href="State">State</a>
<a href="Advisor">Advisor</a> to make any event changes or substitutions, and you will be invoiced an additional \$10 per event change or substitution. This includes, but is not limited to, adding events for students, editing teams, and substituting new students for those already registered who are unable to attend. If you want to drop a student from an event or your roster after the January 21 deadline, there will be no \$10 charge for notifying the State Advisor. However, no refunds will be granted. Notifying us of no-shows is helpful to our planning.

# **POLICIES**

- Late registrations requested after the deadline are not guaranteed and will incur a \$50 late fee.
- If proof of payment is not received before the conference date, a 10% late fee will be added to the invoice.
- No refunds are available for registrations made after the registration deadline.
- Beginning JANUARY 21, you will be invoiced \$10 per event change or substitution.
- Only paid registrants may participate in the Preliminary Round uploads and take written tests.
- NC TSA Conference registration is NONREFUNDABLE. Once registration is submitted electronically, the Chapter is responsible for paying in full for all registered attendees. Ensure that students, administrators, and parents are informed.

# **Forms**

# **Letter of Justification to Administrators - Template**

Please read through the required forms below. Some may need to be reviewed with attendees, while others require a signature, completion, and submission to the appropriate party.

# **Attendee Code of Conduct**

It should be reviewed and signed by each attendee/ parent before the conference. This form is good for the entire academic year.

# **CTSO Multiple Release Form**

Each attendee must complete and submit the form to the Chapter Advisor. This form is good for the entire academic year.

# **Chapter Certification Form**

This form is required to participate in conference activities, including but not limited to the preliminary round, semifinalist interviews, on-site events, general sessions, and breakout/interest sessions. Only one form needs to be completed per chapter per year.

# Completed Chapter Certification Forms must be submitted for Western by February 20, 2026. Upload HERE

If the Chapter Certification Form is not received by the deadline, chapters may not participate in on-site Regional and/or State Conference activities until it is received.

# **JUDGES**

Each chapter MUST provide at least two judges for the regional conference. Chapters are encouraged to identify individuals other than chapter advisors to serve as judges. Please ensure that you complete the following form by February 3rd.

# **Dress Code**

Chapter Advisors and chaperones are responsible for ensuring that all TSA student members wear appropriate attire for the occasion. Adults are also expected to dress appropriately for all TSA occasions they attend.

### **BUSINESS CASUAL ATTIRE**

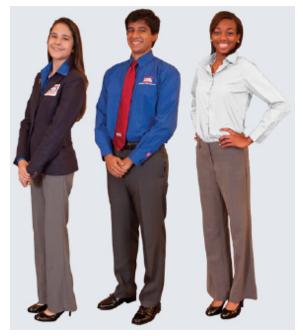
Examples: blouse, polo, button-up, sweater, blazer, slacks, chinos, skirt, flats, loafers, dress shoes

### **UNACCEPTABLE ATTIRE**

Examples: sleeveless tops, ripped jeans, leggings, sweatpants, shorts, flip-flops

# Frequently Asked Questions

This list will be updated regularly with FAQs regarding the North Carolina TSA Regional Conferences in 2026.

### Q: Can you push or extend the deadline for Preliminary Round submissions?

We wish we could push the deadline! We have already lined up judges to start evaluating before the conference date. Additionally, hosting a regional conference has led to 75% of our events now featuring a preliminary round, which means the number of submissions that need to be evaluated has quadrupled. Because of these reasons, we are unable to extend the deadline.

### Q: Why does the Regional Conference cost \$20?

A significant amount of money is being used to host this conference (space and online management systems) and to provide travel for staff. Conference costs include, but are not limited to, facilities, the conference platform, the conference management system, video meeting pro accounts, the conference app, testing, awards, judges' gifts, postage, and additional fees. If you have ideas on how to offset the costs of the Regional Conference, we would love to hear them!

### Q: Where can advisors find the competitive event guidelines and rubrics?

# Q: Does my school have to be affiliated with North Carolina TSA to compete in Regionals?

No. The Regional Conference is open to all STEM and CSITT programs in North Carolina. Schools will need to affiliate with National TSA and NCTSA to compete at the State and National Conferences.

### Q: Is Regionals a qualifier for the State Conference?

No. Regionals allow student members to receive specific feedback as they prepare for the state conference and beyond.
