



Track 3 Established Doula Certification Established Certification Details

Applicable for:

Doulas who have **completed** (i.e. attended every class) the **Core Doula Training through Natural Resources in the past 2 years***.

If you were trained by NR and

MISSED the deadline AND you

meet the qualifications for it you

can become certified via Track 3
the Established Doula Certification

process

Doulas who have a **CURRENT certification**** (from any Doula
training organization) that is
expiring soon and wish to
re-certify with Natural Resources

**There is a 90 day grace period, from the date of expiration. If more than 90 days have passed, completing Track 3, Established Doula Certification, is required.

"Established Doulas"*** who:

- ~ have completed a training with another Doula training organization ~OR~
- ~ have completed a training with Natural Resource MORE than 2 (or 3*) years ago)

~AND~

~ do NOT have a current certification from any organization.
