## **1. WHAT INFORMATION DO WE COLLECT?**

*In Short: We collect personal information that you provide to us*

We collect personal information that you voluntarily provide to us when you express an interest in obtaining information about us or our products and Services, when you participate in activities on the Services, or otherwise when you contact us.

**Sensitive Information:** We do not process sensitive information.

All personal information that you provide to us must be true, complete, and accurate, and you must notify us of any changes to such personal information

## **2. HOW DO WE PROCESS YOUR INFORMATION?**

*In Short: We process your information to provide, Improve, and administer our Services, communicate with you, for security and fraud prevention, and to comply with law. We may also process your information for other purposes with your consent.*

We process your personal information for a variety of reasons, depending on how *you* interact with our Services, including:

- To save or protect an Individual's vital interest. We may process your Information when necessary to save or protect an individual's vital interest, such as to prevent harm

### 3. WHAT LEGAL BASES DO WE RELY ON TO PROCESS YOUR INFORMATION?

*In Short: We only process your personal information when we believe it is necessary and we have a valid legal reason (i.e., legal bases) to do so under applicable law, like with your consent to comply with laws, to provide you with services to enter into or fulfill our contractual obligations, to protect your rights, or to fulfill our legitimate business interests.*

*If you are located in the EU or UK this section applies to you.*

The General Data Protection Regulation (GDPR) and UK GDPR require us to explain valid legal bases we rely on in order to process your personal information. As such, we may rely on the following legal bases to process your personal information.

- **Consent.** We may process your information if you have given us permission (i.e., consent) to your personal information for a specific purpose. You can withdraw your consent at any time.
- **Legal Obligations.** We may process your information where we believe it is necessary for compliance with our legal obligations, such as to cooperate with a law enforcement body or regulatory agency, exercise or defend our legal rights, or disclose your information as evidence in litigation in which we are involved.
- **Vital Interests.** We may process your information where we believe it is necessary to protect your vital interests or the vital interests of a third party, such as situations involving potential threats to the safety of any person.

If you are located in Canada, this section applies to you

We may process your information if you have given us specific permission (i.e., express consent) to use your personal information for a specific purpose, or in situations where your permission can be inferred (i.e., implied consent). You can withdraw your consent at any time.

In some exceptional cases, we may be legally permitted under applicable law to process your information without your consent, including, for example:

- If collection is clearly in the interests of an individual and consent cannot be obtained in a timely way

- For investigations and fraud detection and prevention
- For business transactions provided certain conditions are met
- If it is contained in a witness statement and the collection is necessary to access, process, or settle an insurance claim
- For identifying injured, ill, or deceased persons and communicating with next of kin
- If we have reasonable grounds to believe an individual has been, is, or may be victim of financial abuse
- If it is reasonable to expect collection and use with consent would comprise the availability or the accuracy of the information and the collection is reasonable for purposes related to investigating a breach of an agreement or a contravention of the laws of Canada or a province
- If disclosure is required to comply with a subpoena, warrant, or rules of the court relating to production of records
- If it was produced by an individual in the course of their employment, business, or profession and the collection is consistent with the purposes for which the information was produced
- If the collection is solely for journalistic, artistic, or literary purposes
- If the information is publicly available and is specified by the regulations

#### **4. WHEN AND WITH WHOM DO WE SHARE YOUR PERSONAL INFORMATION?**

We may need to share your personal information in the following situations:

- **Business Transfer.** We may share or transfer your information in connection with, or during negotiations of and merger sale of company assets, financing, or acquisition of all or a portion of our business to another company.

#### **5. DO WE USE COOKIES AND OTHER TRACKING TECHNOLOGIES?**

**Your concern would be whether:**

We may use cookies and similar tracking technologies (like web beacons and pixels) to access or store information. Specific information about how we use such technologies and how you can refuse certain cookies is set out in our Cookie Notice.

FullJc LLC does not track your activities. Only information saved on your device is the settings of the App.

#### **6. HOW LONG DO WE KEEP YOUR PERSONAL INFORMATION?**

We will only keep your personal information for as long as it is necessary for the purposes set out in this privacy notice, unless a longer retention period is required or permitted by law (such as tax, accounting or other legal requirements)

When we have no ongoing legitimate business need to process your personal information, we will either delete or anonymize such information, or, if this is not possible (for example, because your information has been stored in backup archives), then we will securely store your personal information and isolate it from any further processing until deletion is possible.

## **7. DO WE COLLECT INFORMATION FROM MINORS?**

We do not knowingly solicit data from or market children under 18 years of age. By using the Services, you represent that you are at least 18 or that you are the parent or guardian of such a minor and consent to such minor dependent's use of the Services. If we learn that personal information from users less than 18 years of age has been collected, we will deactivate the account and take reasonable measures to promptly delete such data from our records. ## **8. WHAT ARE YOUR PRIVACY RIGHTS?**

In some regions (like the EEA, UK, and Canada), you have certain rights under applicable data protection laws. **Withdrawing your consent;** If we are relying on your consent to process your personal information, which may be expressed and/or implied consent depending on the applicable law, you have the right to withdraw your consent at any time. You can withdraw your consent at any

However, please note that this will not affect the lawfulness of the processing before its withdrawal nor, when applicable law allows, will it affect the processing of your personal information conducted in reliance on lawful processing grounds other than consent.

**Cookies and similar technologies;** Most web browsers are set to accept cookies by default. If you prefer, you can usually choose to set your browser to remove cookies and to reject cookies. If you choose to remove or reject cookies, this could affect certain features or services of our Services. ## **9. CONTROLS FOR DO-NOT-TRACK FEATURES**

Most web browsers and some mobile operating systems and mobile applications include a Do-Not-Track (“DNT”) feature or setting you can activate to signal your privacy preference not to have data about your online browsing activities monitored and collected. At this stage no uniform technology standard for recognizing and implementing DNT signals has been finalized. ## **10. Do California Residents Have Specific Privacy Right?**

Yes, In case you are a California resident, you are granted specific rights regarding access to your personal information.

California Civil Code Section 1798.83, known as the “Shine The Light” law, permits our users who are California residents to request and obtain from us, once a year and free of charge, information about categories of personal information (if any) we disclosed to third parties for direct marketing purposes and the names and addresses of all third parties with which we shared personal information in the immediately preceding calendar year. If you are a California resident and would like to make a request, please submit your request to us using contact information shown below.

If you are a California resident under 18 years of age, and have a registered account with Services you have the right to request removal of unwanted data that you publicly post on the Services. To request removal of such data, please contact us using the information provided below and include the email address associated with your account and a statement that you reside in California. We will make sure

the data is not publicly displayed on the Services, but please be aware that the data may not be completely or comprehensively removed from all our systems (e.g., backups, etc).

#### CCPA Privacy Notice

The California Code of Regulation defines a “resident” as:

- 1) every individual who is in the State of California for other than a temporary or transitory purpose and
- 2) every individual who is domiciled in the State of California who is outside the State of California for a temporary or transitory purpose

All other individuals are defined as “non-residents.”

If this definition of “resident” applies to you, we must adhere to certain rights and obligations regarding your personal information.

**Will your information be shared with anyone else?**



We may disclose your personal information with our service providers pursuant to a written contract between us and each service provider. Each service provider is a profit entity that processes the information on our behalf following the same strict privacy protection obligations mandated by the CCPA.

We may use your personal information for our own business purposes, such as for undertaking internal research for technological development and demonstration. This is not considered to be "selling" of your personal information.

FullJc LLC has not disclosed, sold, or shared any personal information to third parties for a business or commercial purpose in the preceding twelve (12) months FullJc LLC will not sell or Share personal information in the future belonging to website visitors, users, and other consumers.

### **Your rights with respect to your personal data**

#### Right to request deletion of the data – Request to delete

You can ask for the deletion of your personal information. If you ask us to delete your personal information, we will respect your request and delete your personal information, subject to certain exceptions provided by law, such as (but not limited to) the exercise by another consumer or his or her right to free speech, our compliance requirements resulting from a legal obligation, or any processing that may be required to protect against illegal activities.

#### Right to be informed – Request to know

Depending on the circumstances, you have a right to know:

- Whether we collect and use your personal information,
- The categories of personal information what we collect,
- The purposes for which the collected personal information is used,
- Whether we sell or share personal information to third parties,
- The categories of personal information that we sold, shared, or disclosed for a business purpose,
- The categories of third parties to whom the personal information was sold, or disclosed for a business purpose,
- The business or commercial purpose for collecting, selling, or sharing personal information, and
- The specific pieces of personal information we collected about you.

In accordance with applicable law, we are not obligated to provide or delete consumer information that is de-identified in response to a consumer request or to re-identify individual data to verify a consumer request.

#### Right to Non Discrimination for the Excise of a Consumer Privacy Rights

We will not discriminate against you if you exercise your privacy rights.

#### Verification process

Upon receiving your request, we will need to verify your identity to determine you are the same person about whom we have the information in our system. These verification efforts require us to ask you to

provide information so that we can match it with information you have previously provided us. For instance, depending on the type of request you submit, we may ask you to provide certain information so that we can match the information you provide with the information we already have on file, or we may contact you through a communication method (e.g., phone or email) that you have previously provided to us. We may also use other verification methods as the circumstances dictate.

We will only use personal information provided in your request to verify your identity or authority to make the request. To the extent possible, we will avoid requesting additional information from you for the purposes of verification. However, if we cannot verify your identity from the information already maintained by us, we may request that you provide additional information for the purposes of verifying your identity and for security or fraud-prevention purposes. We will delete such additionally provided information as soon as we finish verifying you.

#### Other privacy right

The following are other privacy rights in case we collect personal information, but we do not collect any personal information. These rights are for your reference or information.

- You may object the processing of your personal information
- You may request correction of your personal data if it is incorrect or no longer relevant, or ask to restrict the processing of the information.
- You can designate an authorized agent to make a request under the CCPA on your behalf. We may deny a request from an authorized agent that does not submit proof that they have been validly authorized to act on your behalf in accordance with the CCPA.
- You may request to opt out from future selling or sharing of your personal information to third parties. Upon receiving an opt-out request, we will act upon the request as soon as feasibly possible, but we would like to hear from you.

### **11. Do Virginia Residents have Specific Privacy Rights?**

#### **Virginia CDPA Privacy Notice**

Under the Virginia Consumer Data Protection Act (CDPA)

“Consumer” means a natural person who is a resident of the Commonwealth acting only in an individual or household context. It does not include a natural person acting in a commercial or employment context.

“Personal data” means any information that is linked or reasonably linkable to an identified or identifiable natural person. “Personal data” does not include de-identified data or publicly available information.

“Sale of personal data” means the exchange of personal data for monetary consideration.

If the definition “consumer” applies to you, we must adhere to certain rights and obligations regarding your personal data.

The response period may be extended to once by forty-five (45) additional days when reasonably necessary. We will inform you of any such extension within the initial 45-day response period, together with the reason for the extension.

#### Right to appeal

If we decline to take action regarding your request, we will inform you of our decision and reasoning behind it. Within sixty (60) days of receipt of an appeal, we will inform you in writing of any action taken or not taken in response to the appeal including a written explanation of the reasons for the decisions.
