Opening: Mario - short wrap up from Lisbon ( GEANT PMC Meeting -24-26 October ):

The understanding I have got from the meeting in Lisbon is that we need to produce ASAP an initial Costs-Benefits Analysis to be provided to the GEANT PLM team of GEANT for approval by the GN management.

The final product can be either a toolkit, an hosted IDP at some NRENs, or a GN-provided Cloud IDP solution.

In the meanwhile we can proceed with a basic, initial design of the Campus IDP solution starting from the toolkit.

We will refine the CBA after the first project green light and while running a testbed, and with SA2 on board, working

The roadmap ahead of us, as understood in Lisbon, would foresee:

- Finalization of the NRENs Cloud IdP Survey and input of its outcomes to the Market Analysis deliverable document and CBA ( Dec 2016)
- Initial CBA ready for IdP Cloud for both a toolkit-based and a cloud-based solution splitting for the cloud-based approach a solution based on NRENs and another based on GEANT providing it( by end of March 2017)
- Spend a limited effort a total of 2 PMs in the meanwhile at pace of around 0.5 FTE, in the design phase to carry out in 4 months a draft design for both, toolkit- and cloud -ldP, also to be used to refine the CBA (end of February 2016)
- Get approval (green light) from GEANT management an an indication on what solution to go for ( Toolkit or Cloud), boost a desing and implementation phase for the Cloud/Toolkit IdP already including SA2 in the loop ( SDP / Service Template) ( April 2017 onward )
- Start a testbed for the services, in collaboration with SA2 (May 2017)
- Refine CBA in a many iterations cycle, rediscuss with NA1 Product Management Lifecycle about product perspectives (June-Dec 2017)
- Possible transition to service (Mid 2018)

Janusz: Docker would probably be the best way to go, being independent of underlying operating system. We can create a docker private Registry for Docker - The best approach would be Docker- independent of Cloud-based on running locally on your system.

The problem I have is what to do with User Registry: provide images for LDAP with basic structure or use external source of data, provide both options would be good.

HA won't be hosted at release 0. Also the management of the IDP - to be able to convert our configuraiton in JSON, mapping attributes, source of MD, it will compiled and pushed into IDP configuraiton

When you loose Docker instance, I will be easy to re-create the instance would be easy. A Docker env on its way in HAnet
