

Annual Meeting 2022 Minutes

Call to order at 7:10 PM. November minutes were accepted as submitted.

Reports of officers:

President - Bob

Bob reported:

- GC's conversion to an all-volunteer organization continues to present challenges: e.g., how to contact the management team, how to develop activities, and how to get members to be more active.
- Outreach efforts in the community have paid off. Membership continues to grow.
- The executive committee is now more international.
- We cherish our ongoing partnership with Penn State Global and Ten Thousand Villages.
- We are finding ways to serve the community: partnership with SCASD, especially in supporting immigrant families; assisting refugees.

Goals:

- Develop more in-person activities
- While our financial situation is healthy, we need to generate revenue
- Fill vacant standing committee chairs
- Reconnect with former members and hopefully re-engage them.
- We will need to find a replacement for me when I step down at the end of 2023.

Treasurer – Bruce Truitt

Bruce reported:

1. \$6,600 in a checking account, \$30,713 in the money market account. Holdings with the Centre Foundation is estimated at \$65,000 - \$66,000; expected distribution in March-April 2023 - \$3,200 -\$3,300 (estimated amount, the distribution rate doesn't set yet until the beginning of the fiscal year).

- 2. GC was the beneficiary of the "Centre Gives" in 2022 and got \$845. A big part of that number was generated by our own membership.
- 3. GC satisfied all obligations (was able to meet the fixed and variable costs) and has positive balances, but the cash flow is pretty flat.

Vice President - Kieran Holland

Kieran reported:

 WPS, PBS channel – WPSU and Global Connections are exploring a partnership for December 3rd, 6:15-10:30 PM. We need 5-6 volunteers to answer phones at WPSU. WPSU will be promoting Global Connections the entire evening of this drive. This information should be advertised on the website.

Public relations, website, and social media

Sabrina Lima reported

1. We changed the template of the newsletters, and now we have every monthly highlight on members of the organization and their stories.

Bylaws changes

1. a vote to adopt the following bylaws proviso: "The office of the president will not be held to term limits until after the 2023 annual meeting. This proviso will no longer be in effect upon the conclusion of the 2023 annual meeting."

2. a vote on amending the Bylaws:

Current text: IV.D.4 Duties of the Treasurer. The duties of the treasurer will include receiving and collecting membership dues, maintaining membership records, receiving and collecting programming fees, receiving and disbursing monies with the approval of the executive committee and keeping the financial records of the organization.

Proposed amendment: Delete the phrase "maintaining membership records" and add it to the responsibilities of the Membership Committee Chair in the Standing Rules.

Reasoning: This is not a fiscal responsibility and therefore not relevant to what the Treasurer does. The Membership Chair is already fulfilling this function through the upkeep of records in Wild Apricot.
