Library Book Reconsideration Committee Summary Book Title: Dear Martin by Nic Stone Nov. 9, 2022 2:00 pm

Concern: A community member formally challenged the book *Dear Martin* by Nic Stone on July 22, 2022. Due to summer break and the lack of a formed committee, the Superintendent delayed the procedures outlined in district policy in order to develop a committee which includes employees of the district, until the school year began. The community member communicated that the content of the book should be removed due to the content of "teenage shooting, graphic rude language about women, racial themes unsolvable, teaching that counteract Martin Luther King's wisdom, etc.". The complainant sent a picture of page 31.
