Resolution 3: To insist that the U.S. State Department Office of Overseas Schools (OOS) does everything possible to ensure equal participation, rights and opportunities for disabled students in schools receiving funding from OOS, consistent with standards of the Americans with Disabilities Act

 - Q: Liz Blackburn (China) Will the committee be flexible and inclusive to those who perhaps join mid-year, for a specific project, or cannot participate for a full term? I'd like to ensure any committee created is inclusive to more members, who may have good ideas and varied skill sets.
 - A: Josh Van der Ploeg (United Kingdom) these things will certainly be considered and it is understandable volunteers have limited time to commit through a year. Ideally it would be good to have a degree of continuity to allow longer-term planning through each election cycle, but some volunteers may be interested in assisting with individual fundraisers or for a certain period of time.

 - C: Josh spoke on having professionals in finance sitting on the committee, as well as the importance of oversight and independent audits.
 - Q: How will we find committee members?
 - A: Josh Van der Ploeg (United Kingdom) The committee only requires two appointed members (plus the International Treasurer) and is only required to meet at least twice a year. Even out of the pool of highly active DPCA members, we should be able to find qualified committee members.
 - Q: What qualifications are you looking for?
 - A: The current wording of the resolution asks the International Chair to use "reasonable efforts" to find members with skills and/or experience in finance, but these categories are difficult to define. Qualified candidates may have past experience working as a country committee Treasurer or on a board of a non-profit, even if they do not have formal education in finance.

 - A: Antar Keith (Germany) We are asking for action from President Biden in the form of an Executive Order.
 - Q: Liz Blackburn (China) Do you have a plan for the 2023 AGM and door knocking to meet with any elected officials, staff, or other figures who could help move this effort forward?
 - C: Marnie Delaney (France) There is a one-page document being made for door knocking priorities
 - C: Carmelan Polce (Australia) Historically door knocking has prioritized issues directly affecting Americans residing abroad, perhaps this is more domestic?
 - A: Antar Keith (Germany) I left to live abroad because of the deep divide I felt on many levels, I could no longer tolerate life in America. It was not secure, it was not fair, it was not just. These problems carry with people like me wherever we go, they are systemic and unchanging. We must act now.
 - C: Liz Blackburn (China) I encourage you to sign up for AGM events, speak to Jazz and Jarryd, and look into the kick off event with the Global Black Caucus because members of the Congressional Black Caucus will be in attendance. It would be good to have follow up meetings in the books, online or in person. I will also put you in touch with Brandi Collins-Dexter.
 - C: Kaitlyn Kennedy (Germany) Exciting new we will publish shortly: Cori Bush has issued a statement on Reparations and Restorative Justice.
