## **Course Description:**

U.S. Government: This is a rigorous honors-level class designed for college-bound students. In this course, students apply knowledge gained in previous years of study to pursue a deeper understanding of the institutions of American Government. In addition, they draw on their studies of world and American history, geography, and other societies to compare differences and similarities in world governmental systems today. This course is the culmination of history/social sciences classes to prepare students to solve society's problems, to understand and participate in the governmental process, and to be a responsible citizen of the United States and the world. This course examines the fundamentals of government and citizenship. It focuses on the central ideas, protections, privileges, structures, and economic systems that affect the life of a citizen in the United States political system.

#### **Homework Policy:**

Students will have daily homework assignments, either previewing or reviewing class material. Students in the American Government class will work about 15-30 minutes at home daily. The homework assignments will be announced in class and posted in the course Google Classroom site before the end of the day. Homework is due at the beginning of each class.

#### Late Work:

Students who miss an assignment due to illness have the district-mandated grace period to complete the make-up work. **Late Homework** will not be accepted under any circumstances. All students are encouraged to use Google Classroom and email to plan for the course and prepare for tests and projects. Students who return from an absence on the day of a previously announced test or quiz will be responsible for completing the assessment. Projects are to be handed in at the beginning of class on the due date. Late work will receive a lower grade.



(one grade per day). Any work not completed within two days of the due date will be assessed as not completed and will receive a grade of a "Zero."

### Make-Up Policy:

Make-up work and tests are allowed for students who have obtained a re-admit slip from the Attendance Office or C-148 by turning in an appropriate written excuse. The responsibility for arranging makeup tests and work rests with the students. It must be scheduled at the teacher's convenience within three days of the students returning to class and completed within five days upon return. A student may only miss one class to complete or make up work in another with prior approval from both teachers.

#### **Classroom Procedures:**

## **Participation in Class Activities**

Students are actively engaged in all class activities, ensuring that all activities are complete and accurate to the best of their ability.

## **On Task Conversations**

Student participates in conversations strictly related to all classroom assignments and activities.

#### **Posting/Turning in Assignments**

Students follow the necessary guidelines for turning in/posting assignments and activities. They place them in the correct location and provide the teacher with the required capabilities to see the assignments.

#### **Following Instructions**

Students read and follow all directions for assignments and activities. Students utilize the provided resources and their peer group to clarify questions and prepare more specific questions for the Instructor.

#### **Collaborating/Working with Peers**

Students engage in and work positively with partners in groups. Students maintain partnership responsibilities and avoid the "divide and conquer" mentality. Students ensure that collaborations are meaningful in the partnerships and that learning is enhanced altogether.

## Working Bell to Bell

Students work on all activities and assignments from bell to bell. The student needs to pack up early or move seats. The student makes sure to begin completing homework or double-checking accuracy if time remains. Students engage in completing meaningful work assignments.

 Bathroom/Water: Students are **NOT** given a certain amount of passes to use the bathroom each quarter. Students will be allowed to use the restroom (one student at a time) *unless they abuse* the privilege (go every day around the same time or take longer than 7 minutes).



- 2) Cell Phones: Beginning this semester, Richland Two is a free-to-focus school. This means that students are not allowed to access their cell phones (or other personal devices) from 8:50 am until 3:53 pm. This is now a South Carolina law, and must be adhered to. To ensure that we comply, the following consequences will apply should your child choose not to comply with this LAW:
  - a) Warning: The first time a student is seen with their device, the teacher will instruct them to put it away. That teacher will then make a note of the warning. Refer to the <u>spreadsheet</u>, which will be updated daily to track students who have received warnings.
  - b) Confiscation: If a student is caught using their device again by the same teacher, the teacher will confiscate the cell phone. Provided that the student hands over the cell phone, it will be taken to room C148, and the student will be able to pick it up at the end of the school day.
  - c) Confiscation: The third time that the same student is seen with their device, the teacher will ask for the cell phone. The cell phone will then be turned into C148, and the PARENT/GUARDIAN will need to come pick it up.
  - d) Defiance: Should the student be seen with their device a fourth time, the student will be written up for defiance and receive the proper consequences. This will most likely include suspension \*\*\*If the student refuses to hand over the device after their warning, the teacher will proceed with a referral.
    - \*\*\*While students may receive a warning multiple times, once the device has been confiscated, it is monitored by the school. If one teacher has turned in the phone once, and then another teacher turns it in at a later date, the disciplinary action increases.
