Silhouette AI is a browser-based tool that reads your Gmail messages—via the Google Gmail API—to provide summarisation and productivity features. The Service operates on a freemium model: a core set of features is free, and optional paid plans may be introduced in the future.

You must create an account through our authentication provider Clerk to use the Service. You agree to provide accurate information and keep it up to date. You are responsible for safeguarding your account credentials and for all activities that occur under your account.
