### • Legislative Research Group Update (Sherry Dutzy)

- 2025 Leg Tracking by Cty & LSR Tracking
  - Open to all to add environmentally friendly reps/senators and their contact information and areas of expertise
  - All are encouraged to educate their Reps. on plastics issues
  - Clark is working on getting a meeting with the Governor in December
  - 150 new reps and should be contacted by constituents to see where they stand on the environment
  - Suggest outreach to Rotaries, Chambers
  - Legislation should bring \$ into the state and get business (BIA, nhbsr?) to support our work
    - Best way to achieve support by Rs
    - LSR 2025-0655 recognizes the fundamental right to have clean air, clean water, and a healthy environment.
  - Need volunteers to reach out to their legislators
  - Where to put our influence?
- NH Climate Corps Report Due November 1 (Carol Sullivan)
- Update from Nora Bosworth (Kristine Baber)
  - Nick Germana sponsoring a bill for the right to clean air, water & environment
  - Unlikely to achieve a lot in this legislative session recommends against bag ban and container deposit bill given the legislative climate

- Suggests trying to advance a bill to develop a microplastics testing & reduction strategy or similar
  - RI has been working on this but failed because DES could implement without US
     EPA approved testing methodology for microplastics
- Safer States has a model bill on microplastic reduction in water, soil & the environment

  - ACTION: Kristine will outreach to Sen. David Watters who has been active in water protection legislation
  - ACTION: Mark will research Green Mt. Conservation mp testing efforts
  - A movement exists to eliminate microplastics in consumer products
  - Different issue than SUP waste contaminating the ocean

    - Business Industry Association & NH Businesses for Social Responsibility
    - Consensus to wait on the letter campaign until we have more info from Aldi's
    - ACTION: Susan will contact Dover Aldi's Manager to learn more about their national policy on eliminating SUP bags
  - Campaign effort to partner with grocery stores to reward people for using reusable bags
  - Aldi doesn't use plastic bags (article)
    - Walmart has stopped providing single-use plastic bags in New York, Connecticut, and some parts of Colorado. The company now offers reusable shopping bags for customers who do not have their own bags.
    - Stop & Shop planned to eliminate single-use plastic bags at Northeast stores and is already charging customers for paper bags, CBS NEWS said.
    - Wegmans eliminated plastic bags and shifted customers to reusable bags in 2022.
  - Whole Foods & many co-ops take 5 cents off your bill if you use your own bags
  - Timeline, letter for store mgr, talking points, store sign-up sheet

  - there's a feeling that sending to study is a way to kill a bill guietly
- Be cautious of providing too much information
- With any bill, need to make sure that monitoring and enforcing can be guaranteed
- Campaign "Plastics are Toxic" list a suite of bills
- Polystyrene bill from the state of Washington. Sherry thought this might be worth introducing
  in NH and connecting it with toxins in the containers.
- Reuse Policy Tracker By Upstream
- SUP Bag Ban
  - Single Use Bag Ban in NH
  - Consider reusable bag project
  - Rep. Christy Bartlett sponsored a bill in 2019, <u>HB102</u>
  - California starting in 2026: Pay at least 10 cents for a paper bag; use a reusable bag; or hand-carry their purchase at most grocery stores, convenience stores, and others.
  - "single use plastic" bill may be what was being objected to by the disabled, -- Straws, not bags, are often mentioned as needing an exception for need.
  - Great idea about Slingshot or Community Action Works!!

    - Ban PVC clear packaging it's the greatest contaminant and reduces the value of PET plastic (high value, high use) and the ability to be reused
    - Labels on PET bottles are managed to reduce contamination
    - Tie in with lead issues campaign by CLF and Environmental Justice

- There are many additives in most plastics that are hidden based on the claim of being proprietary. Lubricants, antistats, colors, etc...Most plastics could not do what that do without additives
- Help from NH Healthy Climate
- Support from water quality groups
- Mark's idea of listing hazardous materials in food packaging could be very significant in educating the public about the risks. Representatives and Senators will have little choice but to protect the citizens.
- I think the 'sudden' awareness of the dangers of PFAS should be used as a base.
   'Who knew?...well industry knew the effects of Halogens (Fluorine Chlorine, Bromine) for decades
- I don't know if most folks remember the problem with brominated flame retardants...which was everywhere - cars, kids clothing...this was 3 years ago...and Fluorine (PFAS base) behaves just like Bromine....or Chlorine.(think PVC) ..and industry and academia has known this forever....
- Low molecular weight materials within all plastics- acting like hormones in the body is a relatively new understanding- even by industry I think, but an equally scary thing that most people are concerned about as they should be.
- Collaborate there are lots of advocates working on toxicity and health, go beyond plastics

#### • Fossil Fuel Investments Webinar

- o 99% of Americans are forced to invest in fossil fuels in their retirement plans.
- Almost 20% of investments in fossil fuels come from retirement savings.
- If you took 12 companies including Adobe, Amazon, Apple, Google, Intuit, Meta, Microsoft, Netflix, Oracle, etc: the employees have lost \$5.1 billion due to their companies investing in fossil fuels.
- If you took \$10,000 and invested in fossil fuels 10 years ago, guess how much money you'd have today? \$10,004.
- If you took the \$10,000 and invested in the S&P 500 minus the fossil fuels, you'd have \$34,851!
- Google has invested \$1.7 billion in fossil fuels through their retirement savings. If they hadn't done that it would be like taking 700,000 cars off the road.
- An explanation of why fossil fuel companies are desperate to turn to plastics.
