- How we collect your personal data

- We also retain usage data for internal analysis purposes. Usage data is typically retained for a shorter period unless it is used to enhance security or improve the functionality of our services, or unless we have a legal obligation to retain such data for a longer period.

- Information sharing

We may disclose information collected about you in accordance with your legitimate rights and may allow you to share this information with various third parties in various ways, including:

- Other third parties (e.g., for collaborative products and other purposes authorized by you);
