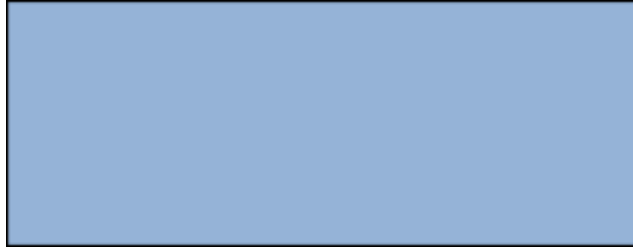


Figure 2: Description of Figure 2
