Below are the Fall Board Policy Updates updates. For the most part, the updates and new policies and regulations are the result of state legislative action during this past legislative session.

The updates are as follows:

Policy 0320 - School Board Elections

This update modifies the mandated qualifications for Board elections. Candidates will not be required to reside in the District for at least the year preceding their election. *Adoption is Mandatory.*

Policy 0342 - Nepotism, Conflict of Interest, and Financial Disclosure

The only change is editorial wording. *No Action is Necessary.*

Policy 0412 - Meetings - Participation by Public

Effective immediately, residents may submit agenda items which will be placed on the Board meeting agenda subject to reasonable limitations. *Adoption is Mandatory.*

Policy 1210 - School Year and School Day

This legislative enactment clarifies make-up days for half-day education programs. *Adoption is Mandatory.*

Policy 1725 - Shared Superintendent - NEW

This is a new policy that permits two districts to share a superintendent. *Adoption is Mandatory.*

Regulation 2240 - Admission and Tuition - Non-Resident Students

This update is mandated by legislation which permits non-resident owners of property within the District to enroll up to 4 children in District schools' tuition free, subject to some limitations. *Adoption is Mandatory.*

Policy 2550 - Dual Credit and Dual Enrollment Scholarships

The legislative enactment increases the tuition rebate for qualified students. *Adoption is Mandatory.*

Policy 2670 - Corporal Punishment - Authorized

For Districts utilizing corporal punishment, parental notice and written approval is required prior to corporal punishment. While not required to be in Board Policy, the statutory changes remove District option to investigate matters referred for abuse. Remember, hotlines are to be made immediately, with no prior District investigation. *Adoption is Mandatory.*

Regulation 2785 – Student Suicide Awareness

This update permits certificated staff to receive professional development credit for suicide prevention in-service, beginning in the 2023-24 school year. In addition, Districts who issue student ID cards are required to include the Suicide and Crisis Lifeline dialing code. *Adoption is Mandatory.*

Policy/Regulation 2876 - Epilepsy/Seizure Disorder - NEW

This enactment known as "Will's Law," requires extensive plan development and training to assist students who have epilepsy or seizure disorders. Although the implementation date is July 1, 2023, implementation will require significant preparation. *Adoption is Mandatory.*

Policy 4130- Certificated Staff Contracts

This update provides for alternative certification and modifies the existing Visiting Scholar Certificate. *Adoption is Mandatory.*

Policy 4150 - Substitute Teacher Employment

This update significantly modifies existing provisions for substitute teachers. The changes include provision of a Substitute Teacher Certificate and allos retired certificated employees to substitute without negatively impacting their retirement benefit, with some limitations. *Adoption is Mandatory.*

Policy/Regulation 4515 - Career Ladder

This update expands eligibility and renews the Career Ladder program. *Adoption is Mandatory.*

Policy 4630 - Staff Conduct

This update mirrors recently enacted changes in criminal law regarding distribution of pornographic material. This addition to our staff conduct policy does not require searches through every library book or every textbook, it is narrowly focused on prohibiting conduct which has been considered to be immoral conduct for years. *Adoption is Highly Recommended.*

Policy 4645 - Classroom Postings and Displays - NEW

This new policy is available for districts that wish to exert reasonable control over what staff post in their classrooms. *Adoption is Highly Recommended.*

Regulation 5620 - Student Transportation Services

This enactment allows transportation of students in motor vehicles other than school buses. *Adoption is Highly Recommended.*

Policy 6118 - State Mandated Curriculum - Mental Health Awareness

This update requires instruction on mental health either in Health or PE sometime during grades 9 - 12. *Adoption is Mandatory.*

Policy 5205 - Removal of Lead from Water Supplies - NEW

Legislature recently enacted and requires extensive testing and remediation of lead contamination, beginning, in part, in 2023-24. The testing is extremely technical and will, in most cases, be performed by certified technicians. *Adoption is Mandatory.*

Policy 6119 - Computer Science Class - NEW

Beginning with the 2023-24 school year, Districts will be required to provide at least one computer science course. For reasons unknown, the new enactment requires extensive recordkeeping and reporting requirements. *Adoption is Mandatory.*

Policy/Regulation 6190 - Virtual Education - Less than Full-Time Equivalent

For part-time virtual students, the enactment loosens restrictions on enrollment and appeal. The legislative mandate effectively removes control input from Districts for their students who enroll in full-time virtual courses. For these reasons, a separate **Policy/Regulation 6191 – Full-Time Equivalent** has been created for full-time virtual education. For the same reasons, we have deleted Forms 6190 and 6190.1. **Adoption is Highly Recommended.**

Policy/Regulation 6215 - Reading Success - NEW

This is a new Policy/Regulation implementing legislation mandating extensive assessment, remediation, training, and reporting involving students with substantial reading deficits. *Adoption is Mandatory.*

Policy/Regulation 6251 - Blind Students Independence, Training, Education - NEW

This new policy provides detailed requirements for teaching eligible students by reading and writing Braille. *Adoption is Mandatory.*

Policy 6273 - Underperforming Test Scores - NEW

This enactment necessitated creation of a new policy which imposes notifications when any District school falls within the lower 5% on the Annual Performance Report. *Adoption is Mandatory.*
