Firearms and explosives appear to damage, however it appears to maintain a technological capability of regeneration through nanomachines. Anomaly body transferred to HCZ holding cell. Internals appear to be undamaged despite all efforts done to it.

Incident Report

At approximately 8:00 CST (2000 Hours), a portal was detected by Class D inside of the D Block cafeteria. Internal Affairs, GENSEC, and Nine Tailed Fox responded initially to the call. Class D was already interacting with the portal upon arrival, where they reported heavy fighting on the other side.

GENSEC volunteered a Master Sergeant on operations to determine the situation on the other side, where a rope was fastened securely around their waist before entry. Within 10 seconds of arrival on the other side, he returned injured from gunfire. His report indicated that the portal was directly connected to the Forgotten Realm, and that hostile combatants, including a Helicopter, was linked on the other side.

IA, under advice from 1LT ‘Amnesia’ greenlit the movement of troops into the portal. Upon arrival, Class D personnel had already terminated hostile combatants on the other side, save for a Helicopter of unknown origin. With immense firepower, the helicopter was brought down with no casualties reported from the foundation. Foundation forces apprehended a pilot in the helicopter after its crash. The pilot appeared bloodied and human in nature, suffering from severe wounds to the torso and face. Attempts by ‘Amnesia’ and Morgan to provide basic medical aid failed, and the pilot was pronounced Dead at the Scene.

The body was transported back to the Site by GENSEC, where it was held in the cafeteria until the operation could be finished. Foundation forces were ambushed by several portals forming above their heads, and operatives of unknown origin manifesting from them. While repelling hostile forces, a SCP managed to destroy the portals above the Forgotten Realm, flickering the portal from the Foundation.

Around 2030-2050 hours, NTF transported the body to Research CC, where it was held for the time being until the situation in FR was dealt with. Within the frame of 2050-2055 hours, the situation in FR was handled. A second hostile was engaged by Foundation and Class D, however it was deemed as a Chaos Insurgent who was quickly dispatched.

At 2100 hours, Amnesia requested the support of Private Thomas I. Morgan to assist in the removal of a communication device from the throat of the body, in an attempt to study. Upon arrival, the body was investigated further by both Amnesia and Morgan, where an artificial Life Support System was found. Further investigation led to the discovery of a power source in the head of the body, surrounded by a gyroscopic array of metal.

Around 2120-2140 hours, the body began to regenerate rapidly. Flesh was closing from presumed Nanites, and the body was closing metal hatches around the chest and head to attempt to get into a combative mode. Amnesia successfully managed to stab the body, and separate the power source from the head. The body became limp and immobile after such action.

Approximately 2140-2145 ; the body has the communication device removed from it. The comms device relayed information such as ;
“The church is waiting for you.”
“Come in, Come in. Do not leave him waiting.”
The name ‘SPECTRE’ was used by the communication device, it is presumed the Anomalies designation is ‘SPECTRE’.

Approximately 2150 ; the body and orb are locked in HCZ in separate containers \ cells.
No further actions reported following the containment of the Anomaly and the power source.
