

Refugee Council USA's Action Toolkit to Welcome Refugees February 2025

Background: On January 20, President Trump signed a <u>refugee ban executive order</u>, suspending the U.S. resettlement program indefinitely and grinding refugee admissions to a halt. Within 24-48 hours, the State Department began implementing the refugee ban, canceling flights for refugees who were already booked for travel. By January 24, the ten national resettlement agencies received a stop work order under the <u>foreign aid pause executive order</u>, directing the discontinuation of Reception and Placement (R&P) services for the approx. 40,000 refugees and Afghan allies already here in the United States. By January 25, the State Department began <u>canceling</u> Afghan SIVs' bookings, set to be resettled by a resettlement agency in the coming weeks. There has been no clarity on an announced waiver for "life-saving humanitarian assistance" and funding <u>remains frozen</u> for many key humanitarian accounts. Across the country, some resettlement agencies have been forced to cut back on basic services for refugees in their first months after arrival.

TAKING ACTION IN YOUR COMMUNITY: Stand Up & Fight Back!

Engage Your 2 U.S. Senators and 1 U.S. Representative in Congress: This <u>Quick Reference Guide</u> and accompanying <u>Refugee Advocacy Toolkit</u> outline how to prepare for and conduct legislative visits with your Members of Congress *via virtual or in person meetings.* You can check out when Congress is "recessed" (in their states and local offices) from <u>the 2025 schedule</u> (recess periods are unshaded).

Activate Your State & Local Elected Leaders: The Refugee Advocacy Lab is leading a #DefendRefuge Campaign, calling on bipartisan elected state and local officials to sign a letter to Secretary of State Rubio and Secretary of Homeland Security Noem, affirming their communities want to welcome refugees.
