

## **Payment, Communication & Delivery**

- **International clients:** Payment via PayPal. I use **US Dollars** as my main currency.
- **Malaysian clients:** Payment via local bank-in. I use Maybank and Touch'nGo e-wallet.
- Payment can be made after I send the first draft.
- I will **NOT** send you the finished product until you pay in full.
- Invoices **must be sent** privately via e-mail for proof of purchase.

## **General Rules**

- You are **NOT** allowed to use my artwork for commercial use. **My artwork can be used for PERSONAL USE ONLY.**
- I will try to respond immediately depending on my schedule.
  - **Excluding Sundays (off day).**
- **It will usually take about 3 days to 2 weeks** to complete **one (1)** commission piece, depending on my schedule, style, number of characters, and complexity.
- **Please provide a clear reference for the artwork.**

- Reference images (i.e. photographs; character reference sheets) are highly appreciated.
- **Please provide clear and detailed descriptions** if you want a specific outcome from my artwork. (i.e. poses, background colours, themes, extras, etc.)
- Major changes are **NOT to be made after the draft is approved.**
  - Any minor changes (i.e. small, unnoticeable details like colour) don't count under this rule!
- Any changes and/or delays in schedule will be informed as soon as possible.
- **I am allowed to use my artwork** for promotional and professional purposes (i.e portfolio, catalogue).
  - However, artworks of real-life people - specifically a client's loved ones - will not be shared if requested.
- **I have the rights to turn down any requests that I am unable to fulfill, or if I am uncomfortable with it.**
- **I DO NOT support, nor do I endorse the use of AI (i.e. MidJourney) to reproduce my work in any shape or form.**

### **3. Copyright**
