3. Guest Cancellation Policy

The deposit is non-refundable. Any additional payments made are also non-refundable should you choose to cancel.

4. Cancellation by Christine Marie Mason

Christine Marie Mason reserves the right to cancel a retreat for any reason. In such cases, participants will receive a full refund, minus any unrecoverable costs. We are not responsible for losses associated with travel arrangements made by participants.

5. Flights
