WHEN YOU PAY FOR A COMMISSION

You agree to have read, understand and agree with my ToS.

- **You confirm you are older than 18.**
- **You agree to not copy, reproduce or edit my art without my written permission.**
- **You agree to not use my art to make profit unless agreed otherwise.**

I WILL DRAW

- **Anthro and feral furry art**
- **Babyfur // Kidfur**
- **Diapers, including diaper usage**
- **Erotic and suggestive images**
- **Adult themes**

I WILL NOT DRAW

- **Underage characters in adult contexts.**
- **Any kind of abuse towards underage characters.**
- **Copyrighted licensed characters**
- **Bestiality**
- **Characters based on real pets in any adult context**

If what you'd like to commission is not in any of these lists you are free to contact me to discuss it. Nonetheless, I do reserve the right to refuse to work on any given idea if I don't feel comfortable with it.

COMMISSIONER'S RIGHTS AND OBLIGATIONS

You are free to post your commission wherever you want! You can turn it into a poster, print it in a shirt or a mug...

- **Your commission is for personal use only unless we agreed otherwise. You may not use the commission for profit.**
- **You may not use your commission for minting Non Fungible Tokens.**
- **If you want to edit the image, you may contact me and discuss it.**
- **You may not remove my signature .**
- **You may not edit, trace, copy, alter or claim any of my work as your own.**

ARTIST'S RIGHTS AND OBLIGATIONS

I, as the artist, reserve the right to refuse any commission inquiry for personal reasons.

- **I retain the rights and licenses of your commission**
- **I reserve the right to cancel any commission in progress for personal reasons (See refunds).**
- **I have the right to post and display your commission anywhere unless we discussed something else.**
- **I will not use your commission for further profit other than advertisement.**

HOW I WORK!

- I announce when I'm open for slots via **Twitter** and **Telegram**. My Direct Messages (DMs) and chats are open and you can contact me there right away with your commission info. Please, keep the conversation professional. If you want your commission to not be published, you must tell me upfront. **Private commissions have an extra fee.**
- Once we agree on the work, I will provide a sketch for your approval. This is your chance to speak up and ask me to change, add or redraw parts of the image. If you are deeply dissatisfied with the Work In Progress (**WIP**), I will redraw the picture once. I reserve the right to auction or reuse the unwanted sketch. Please, be mindful when approving the sketch because:
- After the WIP has been approved, **I will only draw small changes**. I will not edit things that could have been fixed on the WIP sketch. Any further edits will be charged.
- I will finish the illustration within 2 months unless agreed otherwise. Turn around is usually about 2 weeks, but this may vary depending on the workload.
- Once the sketch is approved, I will send a paypal.me link . If you are Spanish, payment via bank transfer is possible and preferred. **By paying you agree to my ToS.**
- I will send the finished illustration to your contact. When you let me know you have received it and you're satisfied with it, or a week has passed without reply, **I will consider your commission completed.**

COMMISSION FILE

I will send you the full size version of the final piece (PNG).

PAYMENT

Payment is made either way

- **Paypal**
- **Bank Transfer (only if you are spanish)**
- **Do not send me payment in advance.**
- **I don't accept partial payments**
- **Payment is final**
- **If two or more people are splitting the payment for a commission, one person must be responsible for gathering all the funds and sending the payment in one transaction.**

REFUNDS

You are only eligible for a full refund if:

- **I cancel the commission for personal reasons**
- **I haven't contacted you in more than 3 months while we are doing business together.**

You are eligible for a partial refund if:

- **You demonstrate to be a difficult person to work with and I don't feel comfortable doing business with you anymore.**
