2. Complete Data and Reporting Transparency

The citizens of Florida insist that complete transparency on all election data except for any personally identifiable information.


Non-US Citizens can continue to vote in Florida

- Current statutes do not require verification of citizenship when registering to vote
- In 2022, a statute was introduced requiring DHSMV to share reports on new driver licenses issued using non-citizen documentation to election officials
- Statute 97.053 needs to be updated to require verification that new applicants have not obtained their driver license using non-citizen documentation
- Statute 97.053 also needs to be updated to require enhanced DHSMV information sharing to identify non-citizens currently on the voter roll
- Current statutes insure anyone identified as ineligible is only removed with due process


Safeguards Needed to Insure Only Citizens are Allowed to Register and Vote

- Driver's Licenses, State ID, and Social Security Numbers are Not Proof of Citizenship
 - > Florida driver's licenses and state ID are issued to non-citizens who can provide many forms of ID foreign passport, green card, and even a notice of hearing from an immigration court
 - > Type 2 and 3 social security numbers are issued to non-citizens
- The Standard Florida Voter Registration Application Verifies Identity Using Driver Licenses, State ID, and Social Security Numbers And <u>Does Not Require</u> Proof of Citizenship
 - > Relies on applicant's affirmation of citizenship
 - > SOE has no access to citizenship status information and cannot verify
 - > Unclear if verified at state level (not required by statute)
- All Florida Residents Including Non-Citizens are Offered Many Opportunities To Register to Vote Using the Standard Voter Registration Application
 - > Online, election offices, third party voter registration, social service agencies

Concern: The State of Florida is saying election material no longer needs to be sent to a verified legal residence. If you don't have or need a legal address, where is the ballot and other election material being sent? Do we want ballot material being sent to nonverified and illegal addresses?

Solution 1: add "legal residence address" to lines 715 and 719.

715 <u>return-if-undeliverable legal residence address confirmation final notices</u>
719 <u>updated or confirmed, including their current legal residence address, or</u>

Solution 2: Clarify that Commercial Mailboxes, Mail Forwarding Services or other business enterprises with a postal mailbox number without a valid legal residential address do not meet Florida standards of residency. Consider using Florida's In-State Tuition and Florida Homestead Exemption evaluations to determine legal residency.

Concern: Many forms of easily-forged documents can still be used to register to vote. Only Government issued, photo ID should be a valid form of ID:

6. Removing legislative oversight on Election Technology

Current law requires legislative review over election-related technology referenced in line 667 of SB7050. This review has been removed which reduces transparency.

7. Hand counting should be permitted

The last sentence of Florida Statute 101.5604 requires counties to use tabulators: "A county must use an electronic or electromechanical precinct-count tabulation voting system." This also places the financial burden of the tabulators on the counties.

Remove the mandate on counties to use tabulators by passing Amendment 6 to PCB SAC 23-01 (HB 7067). This amendment changes the last sentence to read, "A county may use an electronic or electromechanical precinct-count tabulation voting system or may count ballots by hand at the precinct level."
