Privacy Policy

This privacy policy (the "Privacy Policy") explains the information we collect, how we use and share it, how to manage your privacy controls and your rights in connection with our websites and the related mobile applications and services (collectively, the "Services").

The application was created to help users create routes in the form of drawings and use them for training. Please note that all routes are only indicative and when using them you must follow the traffic rules of your country, pay attention to the current road conditions and not follow the route if this is impossible for one reason or another. The application is not responsible for the correctness and relevance of the proposed route, as well as for any consequences of using routes by users.

Information we Collects

We collect information about you, including information that directly or indirectly identifies you, if you or your other members choose to share it with us. We receive information in a few different ways, including when you track, complete or upload activities using the Services. The app also collects information about how you use the Services. There are also several opportunities for you to share information about yourself, your friends, and your activities with us. For example:

- Account, Profile, Activity, and Use Information

We collect **basic account information** such as your name, email address, date of birth, gender, weight, username and password that helps secure and provide you with access to our Services.

Profile and use information

We collect information about you when you choose your goals for Standart workout, do some activities in the app (such as using GPS art templates, creation of your own drawings and route and information on them: distance, time, calories, speed, elevation, number of steps and etc.). We also use the data that you share with the app (about your age, height and weight, as well as information about your lifestyle and sports goals) in order to personalize the application for you and improve it based on audience preferences.

Location Information

We do not track your device location while you are not using the app, but in order to provide our core Services, it is necessary for us to track your device location while you use the app. We collect and process location information when you sign up for and use the Services.

If you would like to stop the device location tracking, you may do so at any time by adjusting your device settings.

- Content You Share

Any content that was created and received using our application can be used by us for our purposes (for example, for marketing purposes or to supplement the content of the application).

- Third-Party Accounts

The app allows you to sign up and log in to the Services using accounts you create with third-party products and services, such as Google, or Apple (collectively, "Third-Party Accounts"). If you access the Services with **Third-Party Accounts** we will collect information that you have agreed to make available such as your name, email address, profile information and preferences. This information is collected by the Third-Party Account provider and is provided to the app under their privacy policies. You can generally control the information that we receive from these sources using the privacy controls in your Third-Party Account.

How We Use This Information

To provide the Services

We use the information we collect and receive to provide the Services, including providing you with the ability to:

- Manage your training. To set your fitness goals and use your training dashboard.
- Show your progress.
- To customize your experience.
- To develop the community and expand the content of the application.
- To protect you and the Services.
- To communicate with you.
- To process your subscription.

We do not sell your personal information. We may aggregate the information you and others make available in connection with the Services and post it publicly or share it with third parties. Examples of the type of information we may aggregate include information about equipment, usage, demographics, routes and performance.

How your Information is Shared

- Service Providers

We may share your information with third parties who provide services to us such as supporting, improving, promoting and securing the Services, processing payments, or fulfilling orders. These service providers only have access to the information necessary to perform these limited functions on our behalf and are required to protect and secure your information.

- Affiliates and Acquirors of our Business or Assets

We may share your information with affiliates under common control with us, who are required to comply with the terms of this Privacy Policy with regard to your information. If the app becomes involved in a business combination, securities offering, bankruptcy, reorganization, dissolution or other similar transaction, we may share or transfer your information in connection with such transaction.

- Legal Requirements

We may share your information with third parties, including law enforcement, if we determine that such disclosure is allowed by the law or reasonably necessary to comply with the law, including to respond to court orders, warrants, subpoenas, or other legal or regulatory process.

How We Protect Information

We care about the security of your information and use commercially reasonable physical, administrative, and technological safeguards to preserve the integrity and security of all information we collect and that we share with our service providers. However, no security system is impenetrable and we cannot guarantee the security of our systems 100%. In the event that any information under our control is compromised as a result of a breach of security, we will take reasonable steps to investigate the situation and where appropriate, notify those individuals whose information may have been compromised and take other steps, in accordance with any applicable laws and regulations as secure servers protect this information using advanced firewall technology.
