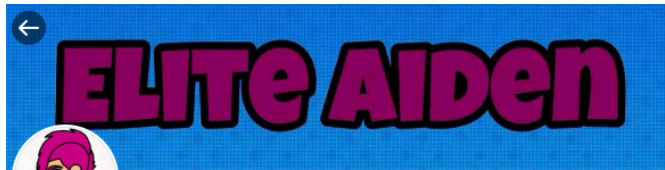

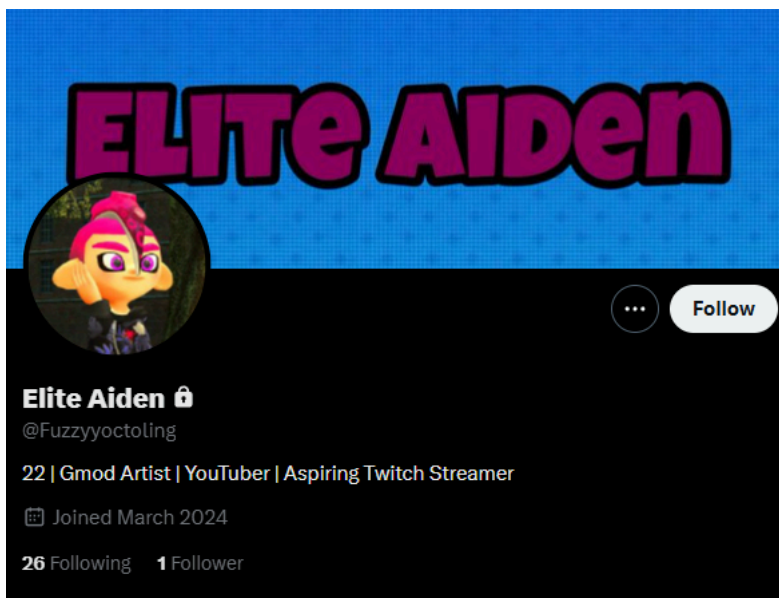

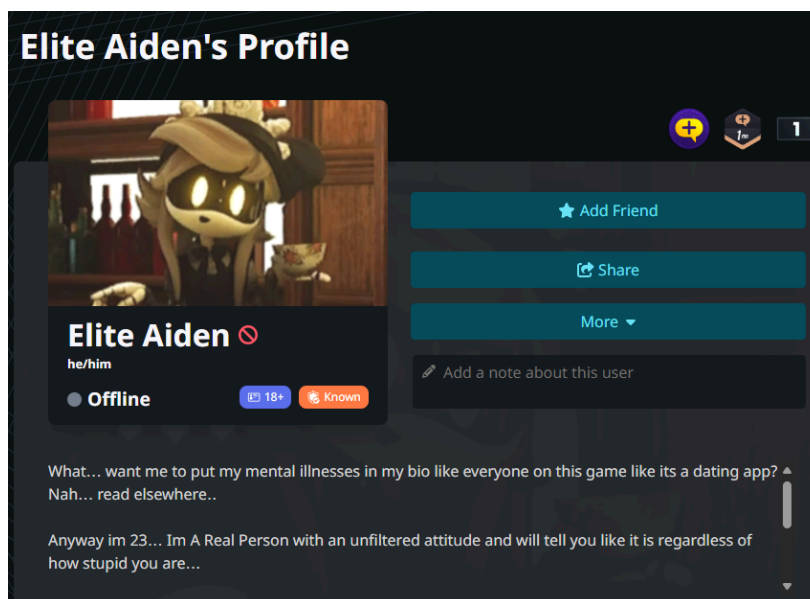

Two anonymous users will be in this and they will be named Anon 1 and Anon 2. Unfortunately people will know Anon 1 quickly because of Aiden's callout, so I will kindly ask everyone to not incite knowledge of them into the public, or else **you are a part of the problem.**

When looking at this evidence, if you defend Aiden just because Anons 1 and 2 are showing unprofessionalism and hostility worse than Aiden, then you are just as problematic as him and need to get your head straight. These pieces of evidence are the raw reactions of a situation and if a victim's reactions are more of your concern than Aiden's toxic behavior, then leave this document and do not interact with me, Aiden, or anyone else about this.

There is no present DM evidence, but it has been cited in a private friend server that will also remain anonymous. Anon 1 has spoken about Aiden feeling a certain way against Anon 2 for showing loyalty and protection for Anon 1.

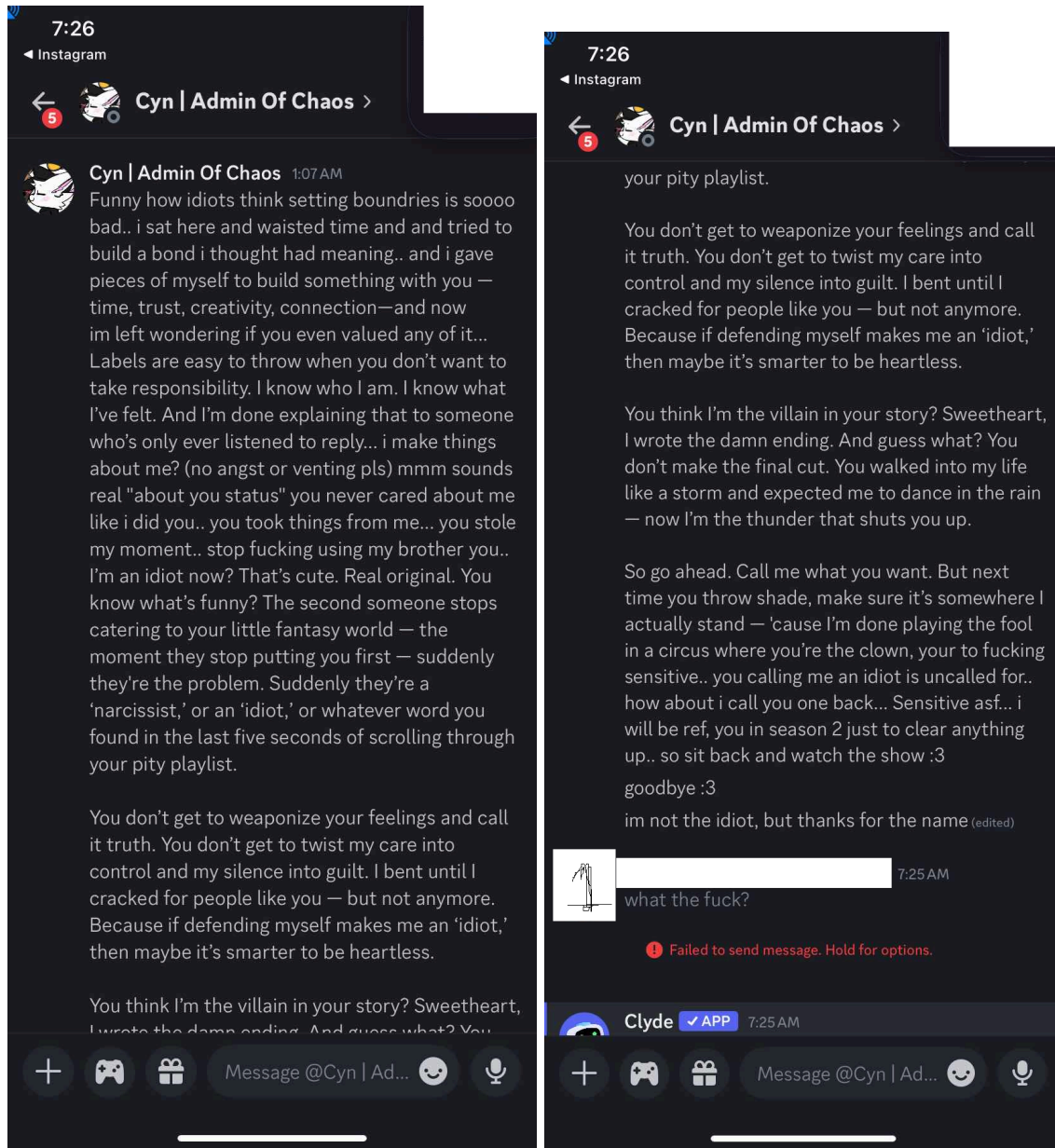

After the argument, Aiden sent Anon 1 this as retaliation to Anon 1 telling him off for considering Anon 2's personality an attack against him.



In these shots, Aiden is shown turning the disagreement into a whole story making everything metaphorical, and blocks Anon 1, proceeding to call for a new voice actor on YouTube while subtly foreshadowing the argument.

Meggy's an important character to me, and I want her to be voiced by a real person who can bring that emotion and heart to her.

If you or someone you know is interested in trying out Please reach out to me on Discord "eliteaidenyt" Also, I won't be using A Certain Person for Meggy's voice anymore due to personal reasons and things that happened behind the scenes. I won't get into details, but please respect that decision. Thank you

Also, said ex friend is a hypocrite because he on multiple occasions has vented to me without my consent about his SA and grooming trauma when that is a very triggering topic for me and yet he thinks I'm sensitive for not wanting to be the fucking therapist friend because I personally cannot deal with this shit anymore and am borderline suicidal.

Keep the words "**without my consent**" in mind.

Anon 1 was going through stuff at the time and never asked for Aiden to vent to them about his "PTSD". Mind you, this stuff does NOT excuse Aiden for his disgusting behavior against Anon 1 and his insulting comment against Anon 2.

Once the callout was posted, Aiden made a callout post retaliating and twisting the story up so he could be loved and supported while Anon 1 got the blame.

I typically avoid bringing personal matters into the public space, but due to recent public accusations made about me, I feel it's necessary to address the situation honestly and professionally.

Firstly, [REDACTED] and I are no longer friends or collaborators. Our sibling relationship ended due to ongoing communication problems and a level of disrespect I could no longer tolerate. I made several efforts to resolve things privately and respectfully, we agreed to stop talking for a bit. BUT Unfortunately, those efforts were met with public attacks In her discord Bio, exaggerated claims, and personal insults (name calling) instead of constructive dialogue.

To clarify, I did not block [REDACTED]—I removed her from my Discord contacts, which is a setting that prevents further messages. This was done to maintain my boundaries and peace of mind.

The message I sent previously was prompted by seeing the phrase "fucking idiot" in her Discord bio. While my response may have been immature, I felt justified because disrespect was directed at me first. You do not get to disrespect me and then act like you've dominated the conversation, especially after calling me a narcissist, words do in fact hurt, and will affect me for the rest of my life Due To PTSD. I am open to a mature conversation, but if that's not possible, I prefer to remove myself from toxic situations, so therefore i am in the right.

Regarding the voice lines issue: I never "used" anyone's work unfairly. Decisions were made based on availability, consistency, and what was best for the project at the time. [REDACTED] sent her lines late, had minimal communication, and I had to move forward as any responsible creator would. This is not betrayal—it's managing a project efficiently.

I did check in with her several times and cared about the relationship we had, but I chose to step away for my mental health when the environment became emotionally draining. Constantly having to navigate someone's volatile feelings while trying to be honest can be exhausting.

It's important to recognize that trauma is something we can heal from—it doesn't have to define or control us.

[REDACTED]'s behavior during and after our fallout has been unprofessional and hostile. Being called a narcissist and other names was unwarranted, so I defended myself appropriately, and i have every right to do so.

I am not here to drag anyone through the mud. However, I will not stay silent when my name is misrepresented. Respect is a two-way street, and I expect the same respect I offer to those I work with. The moment name-calling begins, that line is crossed—and that is why we have parted ways.

That said, I acknowledge that [REDACTED] is angry and hurt. She is twisting my decisions and using past issues as justification to paint me as selfish or a villain, which is not the case.

Claims that I treat voice actors poorly are unfounded. I communicate clearly and work with people professionally, often showing leniency with deadlines and line submissions.

To be clear: [REDACTED] initiated the name-calling and aggression. If I fired back, it was in defense. Accusing me publicly while insulting me only harms her own reputation.

I have said my peace and walked away. I am focused on building meaningful projects with people who act professionally and positively.

I understand that a negative interaction triggered a strong reaction from Her, but framing me as the "bad guy" without hearing my side or allowing space for discussion is unfair. Relationships—whether friendship or collaboration—require mutual respect and understanding, which I feel has been lacking recently and it has.

Regarding the voice lines from last year: decisions about casting were made based on availability and the needs of the project at that time. It was never about "giving anyone the Celeste Notley Smith treatment." recasts did happen across Season 1—not just with her. It was never about favoritism or disrespect. I believe everyone deserves a role and a chance to shine, and I continue to stand by that moving forward. I am sorry if [REDACTED] felt overlooked or unsupported during a difficult time. That was never my intention, but communication could've been present during that and it wasn't. all she would say is "cant, got stuff going on" So therefore making it like "your unavailable" and you were not.. truth be told

When someone commits to a voice acting role, especially for a project that's actively in production, there needs to be clear communication and follow-through. Simply saying "can't, got stuff going on" with no timeframe, no updates, and no clarity doesn't work in a production setting. I completely understand that people go through things—and I respect real-life responsibilities—but if someone doesn't communicate consistently or meet the deadlines agreed upon, I have to move forward with someone else. That's not personal—that's how creative projects function.

She made it sound like I ghosted her or discarded her work without care, when in reality, I waited. I checked in. And when it was clear I wasn't going to get the needed lines in time, I cast someone else to keep the project on track.

This wasn't "treating her like dogshit." It was making a responsible decision as a creator trying to meet deadlines and keep my team running. If that offends her, I can't help that—but I won't apologize for being professional.

As for using the character [REDACTED]: I respect intellectual property and consent. If you no longer wish for the character to be used, I will honor that and make the necessary changes.

she will make one final appearance, then after that, no more [redacted] :) also and So to claim I "can't" use the character is simply untrue—especially when her design is still rooted in Nintendo's property. If anything, none of us legally "own" her. And unless Nintendo themselves step in, trying to sue me or throw legal weight around over a fan character is just empty noise.

[redacted] will no longer be associated with any of my work. I wish her well but will not engage further in personal drama. My priority remains creating, collaborating with positivity, and moving forward with integrity.

Thank you to everyone who has supported me and continues to understand the bigger picture.

I've said what needed to be said. I'm not here to fight or stay stuck in the past. I'm moving forward with a clear conscience and a peace of mind. I've learned, I've grown, and I refuse to let bitterness hold me back.

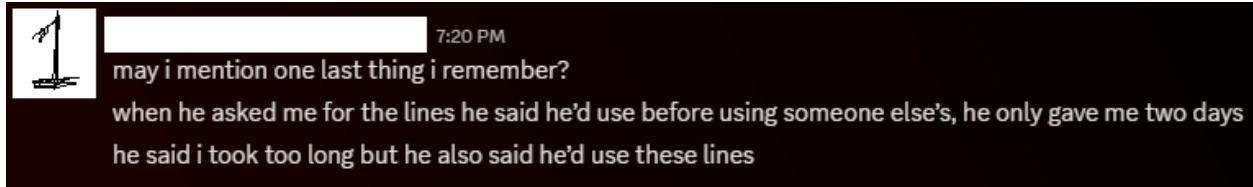
Please do not and i beg you, who all watch my content Please do not comment on her post or send her hate on my behalf. I'm handling this situation maturely. I don't support harassment or retaliation of any kind, no matter what was said or done. Let's move forward with respect, not hostility.

Summary

Aiden has twisted everything to make everyone believe that Anon 1 was being disrespectful instead of him. No, Aiden did not "remove her from [his] Discord contacts", he BLOCKED her and threw a guilt tripping story line for her to read before blocking her. He is mislabeling this argument like him being attacked is a crime to the universe and calls her confrontation on him "domination", whilst using the mental disorder excuse of having PTSD to guilt trip and cover up his ugly actions under the rug. To add to that, the voice lines issue is a **false lie**. Anon 1 has reminded Aiden multiple times that they would be busy with their work shift along with other things, and Aiden has not remembered it, instead proceeding with the process, recasting Anon 1 without notice, and then ghosting Anon 1 afterwards just because it's a protocol. Regardless of lack of communication, the one hosting the project should know better than to do these actions, not the casted voice actors. **That's not professional, that's throwing your crew members into the trash for no reason. And speaking of Celeste, you just committed the same actions Kevin did; Throw Celeste away without notice and recast her character with Lottie.** If anything, when a deadline is ten or five days away, a prior warning should be given for each day. Seems like Aiden has done none of that. The "do not harass anyone" rule in this post is meaningless, as Aiden has done nothing to handle his blind defenders, rather than say this just to close the book.

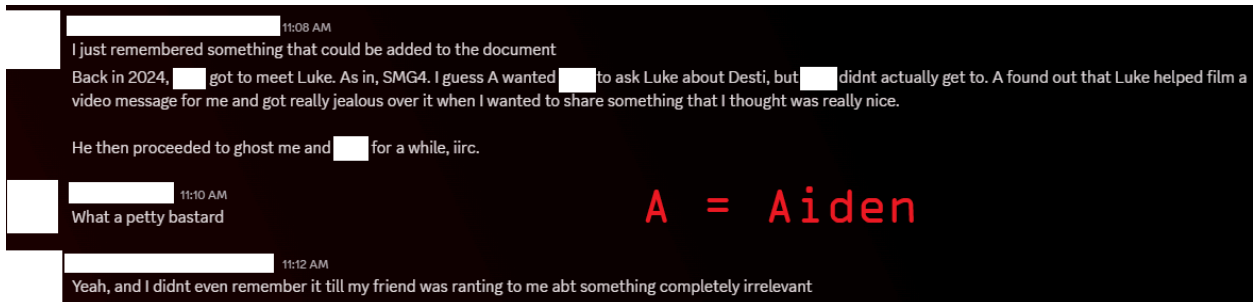
After the callout was posted, Anon 1 posted a retaliation post against him, **but was harassed by defenders into silence making them take it down.** This proves further that Aiden is a disgusting liar and many blind defenders in the SMG4 and Splatoon fandoms are also as dumbed down as he is.

It was also confirmed more on the voice lines issue that Anon 1 was given a super short timespan before her expected deadline, hinting more on Aiden's unprofessional behavior.



Some extra evidence provided by Anon 1 also hinted to Aiden's toxic unprofessionalism, being jealous instead of happy about Anon 1's gift from another friend they had and ghosting them afterwards because of being petty over it.

The fact that Anon 1 didn't remember proves further that Aiden's toxic behavior is actively making Anon 1 suppress memories to tend to a misunderstood trauma-coping mechanism called **fawning**. This is NOT GOOD by all means and is full-on manipulation mechanisms of narcissism.



Conclusion

With all this presented, all I have to say is that Aiden is an immature, toxically regressed user who has no proper care for his friends whatsoever, and throws them to the dump when an argument or disagreement happens, twisting all of their accusations against him into accusations against his victims. Twenty three years old by the way, and this is immature behavior coming out of him. No matter the fact that we're supposed to move on from this, these anonymous users will NOT move on from this at all and will forever be damaged by Aiden's selfish behavior.

Aiden, you are a disgusting human being and nobody is gonna care or cater for your PTSD or for your issues no matter how much you beg and beg to be special. You are not Anon 1's special brother figure and you'll never be, as you have caused so much turmoil to the point where you have instigated Anon 1 to hide-regress after a panic attack and a mental breakdown. I bet Anon 2 is disappointed at you for viewing them as an attack against your ego, when you're the self-absorbed person here. All your actions are considered **narcissism**, and you won't be welcome in the SMG4 fandom and the Splatoon fandom anymore. **You try to mess with both anons' privacies and name-drop them, you WILL face dire consequences for doing so and will be labeled as a stalker if you put their names in public once more.**

This will NOT be taken down, as you have wasted all your chances to act right. Do not come near us ever again.

DO NOT HARASS ANYONE INVOLVED. IT IS A BAD EXAMPLE OF EXPOSING SOMEONE, AND YOU ARE A PART OF THE PROBLEM IF YOU'RE GONNA HARASS TO GET YOUR WAY, AS PEOPLE WILL GET THE IDEA AND HURT OTHERS. YOUR NAME ALONG WITH MORE EVIDENCE WILL BE PUT IN THIS DOCUMENT IF YOU REFUSE TO COMPLY WITH THIS RULE.
