<p><b>Rule B(1)(c) CERTIFICATE</b></p>	

First Middle of the SURNAME family demands lawful money in every possible transaction. The clerk of court is denying First Middle access to the USDC Court of Western Washington. This is cause for riot and initiates Provost Marshal jurisdiction off the military bases.

The Certificate is considered FILED as of February 17, 2026 but there is no filed stamp and the clerk of court refused to accept the \$52 filing fee. It is difficult to prove through PACER and otherwise that this process is valid. US Supreme Court Rules:

***Rule 29. Filing and Service of Documents;***

*2. A document is timely filed if it is received by the Clerk within the time specified for filing... or if it is delivered on or before the last day for filing to a third-party commercial carrier.*

PROCESS SERVER PROCESS is a professional process server and Mel PROFESSIONAL arrived with the filing fee and clear intention of filing a CERTIFICATE that is clearly allowed by the FRCP Supplemental Rules of the Court. The clerk is out of order to refuse to file the papers.

The Title 18 statutes violated constitute federal felonies and misdemeanors. Arresting or attempting to arrest the Process feels like arresting the process server. Even if the process of Certificate of Exigent Circumstances is incorrect for these circumstances, First Middle has the right to pay \$52 and initiate process. According to Congress the clerk may forward the process, once filed to a federal judge for review. The "Chief Judge" deviant oath of office is included in the filing REFUSED FOR CAUSE and this may be why everybody is frightened about what is going down here:

*Arrest of a process server.*

Title 18 USC §1501 - Whoever, being a clerk of a district court of the United States, **willfully refuses or neglects** to make **or forward any report, certificate, statement, or document as required by law**, shall be fined under this title or imprisoned not more than one year, or both.

Even inquiring of the process server about, "What are your intentions? What are you trying to do?" is out of order considering the process server is not interested in the case, and the clerk of court is not making any legal evaluations or in capacity of giving legal advice.

The clerk used the setting, United States Federal Court for intimidation - security, armed guards etc. to deflect a Certificate that was intended to go into the Court.

***Key Aspects of 18 U.S.C. § 1512 (Witness/Evidence Tampering)***

- ***Prohibited Actions:*** *The statute covers knowingly using intimidation, threatening, or **corruptly persuading** another person, or engaging in **misleading conduct** with intent to influence, delay, or prevent testimony, or to hinder, delay, or prevent communication to law enforcement regarding a federal offense.*
- ***Tampering with Evidence:*** *Subsection (c) makes it a crime to corruptly alter, destroy, mutilate, or **conceal a document** or object with intent to impair its integrity or **availability** for an official proceeding.*

- **Scope:** *The law applies to **official proceedings**, including those before Congress, executive departments, administrative agencies, and **federal courts**.*

The clerk of court has shirked an important fiduciary responsibility by shorting the stock of the United States by refusing to accept a \$52 check from PROCESS SERVER Process that is good money. The United States is now in breach of trust because of the clerk's irresponsible behaviors. The Clerk of Court is malfasant:

*Title 18 USC §2076 - Whoever, being a clerk of a district court of the United States, willfully refuses or neglects to make or forward any report, **certificate, statement**, or document as required by law, shall be fined under this title or imprisoned not more than one year, or both.*

Two attempts were made on February 17, 2026. On the first attempt the clerk said he could accept the check but nothing was going to become of the process (unsolicited legal advice). Mel returned and attempted shortly after that and was told the clerk would not accept the \$52 and again refused to accept or file the paper.

Denial of access to the courts is no light matter. First Middle has a right to get his cause, right there in the Rules of Court, into the USDC District of Western Washington. If this Certificate is refused on this third paid attempt to FILE, the filing will be served on the US Marshal and the entire package with a subsequent Statement by PROCESS SERVER about details. The Provost Marshal for Washington state, and the US Provost Marshal will be added to the Address List as denial of access to the courts initiates rioting, and that extends military jurisdiction by martial rule off the military bases.
