Agenda Item and Discussion

1. Resignations from the Board/Committees

Committee members expressed some disquiet about the ongoing lack of information about the reasons for the resignations of the previous Hon Secretary and Chair and asked for clarity. Their resignations were for personal reasons.

Alen Scropetta's recent resignation as the new Hon Sec was mainly for personal reasons and we wish him well for the future.

There remains a difficulty working with HSBC in successfully changing signatories on the club account.

2. Club Sub-committees

Meetings of these appear to have fallen by the wayside. This means that there is little feedback to the Board, which in turn means that items which could be decided at Sub/committee level are taking up a lot of time in Board/Committee meetings unnecessarily. AS said that committees are able to decide on actions within their budget without discussing with the Board, unless the action is seen as a major item or expense

3. Court Maintenance

Thanks to the Facilities Committee for arranging for courts 1 to 3 maintenance. Courts 4 to 6 maintenance to commence 25th August.

In the future the replacement of the surface of courts 4 to 6 should be discussed with the membership at an appropriate time. It was suggested a survey offering options such as:

- Keep all surfaces as they are
- Replace courts 4 to 6 with clay
- Include a brief description of the positives and negatives of each surface.

6. Tournament 2025 Update: PS

263 players entered

497 entries



50 events advertised and 39 going ahead

442 matches to be played

One of the longest tournaments in the UK, lasting 133 days

83 matches to be played to provide a full roster on finals day Sun 7/9 - this is manageable

Anita and Ben Kofi have been very helpful in chasing people to play their games Total revenue £3,096 (+/- 1% because we are not thorough about ensuring everyone pays)

As in previous years:

- We are on target to break even
- Pat has the catering organised and under control

7. Coaching Report: RF

The club's futures Squad has had a successful indoors and outdoors season 3 Local Primary Schools have been visited and 32 children were invited to take part. This has been whittled down to 20 taking part in Project Futures. 10 children have started their Futures journey.

25 juniors are taking part in the Berkshire County closed championships coming up Junior coaching groups are full

Adult cardio group is full

Adult Beginners Group is full

There are a few places available in the Improvers and Advanced Adult Groups 96% occupancy for the summer camp.

Lewis Brown is undertaking Level 4 training, which he is enjoying

Lauren Paris-Jones has joined the coaching team and has agreed to stay in Sept. She is moving towards Level 3, but has been advised to progress to that after she has completed her Master's Degree. Gregor Webster, (Club Champion) has joined the coaching group over the summer holidays

Gauri has left coaching at the club.

Amber is currently trying other work experiences but still helps out at at Ladies Team practice.

8. Ladies Captains Report AM (in absentia, not read out at the meeting)

Ladies teams doing very well with all teams finishing mid to top of their leagues. Shout out to Su Reid who has overseen the 5s getting promotion (and being a big part of that team).

We were due to have a large whiteboard or similar to put at the entrance to the club on match days, this hasn't happened, will it?

I also wanted to repeat that Catherine Botwright and Rosie Morton will be stepping down as Ladies Vets teams captains at the end of this season. We need someone to take over this role. This isn't something that I am willing to take on, though I would of course help any new vets captains however I can.



9. Any Other Business

• Use of Bar: MB

There is poor attendance at the bar which is losing money. It was felt this might be due to changes in the drinking culture, changes in lifestyle preferences for younger members with families and proposed changes in drink driving laws.

PS mentioned that the café/bar at the Padel courts was well used, with a better ambience. The bar serves coffee and croissants etc as well as alcohol and players must walk through it to get to the courts.

It was suggested that it might be relevant to implement a membership bar survey in the future.

Social Tennis

Keep an eye on court allocation, if not all courts being used it is possible to play arranged matches but players must come off as soon as the court is needed for social tennis.
