#### **Financial Update**

As expected, December was bad. £7k loss (bit bigger than we'd have liked, £4.5k last year, £6k year before that). Shop was closed for a bit too long - 2 days longer than last year. Beginning of Jan was relatively busy.

Extra £1k outgoings from pay rise in December.

Overall picture is still healthy.

Reserves are currently slightly below 4 months, take no action now and review with January's figures.

New grant for ASB - equates to about £700 per month over two years. We have received this whole amount already.

The supporters scheme is live and supporters are trickling in. There was a push for EAB donations over Christmas.

Question about holiday allowance: does everyone have to take leave over Christmas? We don't have a policy.
