Public Art Proposal
Fourth Quarter - 2025 Call

The Glen Eden Public Art Committee seeks multiple artists, or artist teams, for two *permanent murals* at the sites located for this call to create new artwork for public viewing on the corporation-owned grounds of Glen Eden.

Timeline

The ideal completion for the artwork's placement will be on or before January 31, 2025, weather permitting. The artist selection will be completed by:

- October 1, 2025 - Artist Call Opens
 - October 31 at 11:59 pm PST - Artist Call Closes
 - Early November 2025 - Finalists will be notified and declinations sent
 - November 16, 2025 - Selected artist(s) will be announced at the Corporation meeting.

Location

The mural(s) will be placed at one of two locations:

- Site A: On the large electrical box to the right of the gym, or
- Site B: On the shed behind rental unit 2

See attached images below for targeted location and measurements of area to be dedicated to the artwork. Both locations are on well traveled roads.

Project Description

The artwork selected for these locations will be permanent, until/unless Glen Eden decides on a change. The proposed mural must aesthetically enhance the surrounding environment. Murals can encompass all four sides, one side, a combination of solid colors on some sides with a mural design on other sides, etc.. - this is open for interpretation by the artist.

Audience

All Glen Eden public art projects will be viewed by a broad audience which includes Glen Eden full-time residents, visitors and campers, all of whom enjoy the nudist lifestyle, as well as employees of the corporation.

Total Budget

The artist/team are responsible for their own items, as well as fabrication and installation from beginning to end. This may include, but is not limited to, travel, costs associated with the design such as engineering approvals, materials, fabrication, delivery, site preparations (outside of what Glen Eden can provide), physical installation, and liability insurance.

2. For non-online artists, a hard copy of the public art packet is available from the Glen Eden Sun Club office.

Choose one or the other, not both. Complete applications will be considered at a higher priority than those that are missing content.

The applicant will be asked to submit design idea(s) for the project, images of similar art by the applicant, a resume/CV, and a brief statement of interest. There is no application fee to apply.

Artists from all identities, backgrounds, and abilities are encouraged to apply. Artists groups can work together as well, and only one application for the group is required. Existing public arts experience is preferred, but not required for this call for entry.

Site Details and Information

Site A: Located between the gym and site #524. Three sides can be viewed from the road. The fourth side when walking from the board room. The owner of site #524 is hoping for something pleasant to look at everyday. Please walk the site and take in this information before coming up with your design.

Site B: Located behind rental property #2. Two sides are easily viewed from the road. The other two sides, by the occupants of the rental units. There is some purple bougainvillea in front of part of it. Please walk the site and take in this information before coming up with your design.
