
# VISION SCREENING FOLLOW UP

Pathway: Main Menu > Health Office > Student Health > Follow up

Information received after a student has been evaluated for an abnormal vision screen is documented in the Follow Up tab.

Do NOT use the follow up button located in the screening tab.

# Required fields (in red below)

- Status Date and Time automatically populates with today's date.
- Vision Diagnosis Code: select choice from the drop-down menu (see page 2 for details).
- Vision Resources: select choice from the drop-down menu (see page 3 for details).
- Glasses Prescribed: Use drop down arrow to select Yes or No.
- Surgery Recommended: Use drop down arrow to select Yes or No.
- Vision Comment: Enter any pertinent data. If surgery is recommended, indicate which eye
  and what type of surgery.
- Click Save.

Vision Diagnosis Code - if a student has glasses, this is why

### **VISION DIAGNOSIS CODES**

Code	Vision Condition	Definition
АМ	Amblyopia	Loss or great reduction in vision in one eye. Often the result of uncorrected vision problems (large difference in visual acuity between eyes) in pre-school years. If amblyopia is diagnosed (no matter what else is diagnosed) code as AM.
МІ	Muscle Imbalance	Eyes that do not work together. Diagnosis might be strabismus, exotropia, esotropia, anisometropia. If amblyopia is not diagnosed and muscle imbalance is diagnosed (no matter what else is) code as MI.
N	Normal	If child is referred as result of school vision screen and is found to have normal vision by eye doctor.
NI	No Information/ Incomplete	Indicates no information about the disposition of the referral or the child is scheduled for a summer appointment with the eye doctor.
0	Other	Use this for conditions that do not fit other definitions, but affect a child's vision. Examples might include cataracts, congenital glaucoma or injuries to eyes. (Do NOT use "other" for students who refuse to wear their glasses or glasses need repair or are lost. They should have the vision diagnosis code for the reason they should be wearing their glasses).
RE	Refractive Error	Myopia (near-sighted), hyperopia (far-sighted), astigmatism (irregularity of surface of cornea). If student received an eye exam and glasses but no follow up information was submitted assume refractive error.

**Note**: "Other" is not used for students who refuse to wear their glasses, their glasses need repair or are lost.

**Note**: The parent/guardian should be contacted if the student is not wearing their glasses or contact lenses. The school nurse will provide assistance in getting resources to the family in cases of financial hardship.

# Vision Resources choices from the drop-down menu

Note: Please DO NOT write in any other information into this field. The drop down menu was created for data collection purposes. With the exception of a Private Provider, each option is a vision resource that requires completing an application or obtaining a vision voucher. If you do not request a voucher or assist a family with a vision resource application, then the answer to this question is that a student saw a Private Provider.
