Spring blade (MW) (teak wood/ivory handle with two small gem stones as buttons to release the blade), Pair of Masterwork Daggers (shark heads on them), Silver Necklace with small blue crystal tear drop, 2 doses of antivenom, vial of poison (5 doses). Gold Earring (15 to 20gp), pouch of coins - 15gp (new - keoish), 35sp/50cp mix of different coins and all old. Bead bracelets (4) each worth about 1 to 2 sp each.	Off of the stranger that attempted to ambush you and who poisoned Thout. (House Party)
Three men with the strangers - all coins poured into one pouch - (12 gp (all new - keoish), 19sp and 45 cp (all old/worn)).	Off of the bald tattoo'd man and the two young men that died ambushing you with the stranger you captured.
River Opals (4) - 30 to 75gp in value each. four gold coins (Keoish minted	Found in Assassin's boot
