The categories of personal data we may collect include:

behavioral usage of the App.

device identifiers (such as IDFA, IDFV for Android, GAID for IOS).

email address.

the type and operator of network (such as Mac address).

the type, version, brand, language and operating system of device.

2.How we use your personal data

We use your personal data including for the following business purposes:

To provide you with and operate, maintain, optimize, and improve our Services, operations, and the security of our Services.

To detect, investigate, and prevent activities that are unauthorized, may violate our terms and policies, or may be illegal.

To respond to your questions submitted to us and provide user support.

To maintain legal and regulatory compliance.

3.Disclosing your personal data to third parties

To the extent necessary or appropriate and without notifying you, we may disclose your personal data to external third parties in the following circumstances:

To members of our group companies.

To third parties we employ to perform business functions and services on our behalf, such as data storage facilities, analysing data and producing statistics and legal, accounting, audit and other professional services.

4.Your privacy data rights
