Dr. Krystal Banfield opened the meeting

- Minutes – Ms. Marie St. Fleur moved to accept the minutes of the March 18th meeting; Ms. Sonia Alleyne seconded. All voted in favor
- The Board Meeting Calendar was presented (dates above)

School Site Council

- **Head of School Report**
 - Mr. Tyrone Sutton thanked Dr. David Bogan and Dr. Krystal Banfield for the graduation at Berklee
 - BAA closed the year with 33 shows!! In addition, they held the first-ever Spring Arts Festival
 - The school is currently planning the calendar for next year
 - Congratulations to Mr. Michael Bradley for the Spiritual Ensemble at Carnegie Hall and for being nominated for a Stellar Award (Gospel recognition night – Nashville in August).
 - It was an amazing experience for the students to perform in Carnegie Hall
 - Also, the Ensemble competed in Atlanta and took home multiple awards!!
 - There is a partnership with the Huntington Theatre. On July 10-26 at BAA there will be a production of *Kufre N'Quay* (12 BAA students are in the show)
 - The SY25-26 Budget is almost finalized
 - First round was done with BPS in December and approved in January
 - Second round will be approved by BAA Foundation Board in June
 - Total operating budget: \$10,084, 297 (From BPS: \$7,546, 484; From BAAF: \$2,497,182)
 - Mr. Sutton summarized the overarching goals for the strategic plan for SY25-26
 - Focus resources and decisions on the overarching priority of student success
 - Provide teachers with opportunities for academic, artistic and professional growth
 - Research and propose future BAA leadership and organizational structures
 - Investing in Teacher Professional Growth and Inclusion (2 new positions)
 - Arts curriculum and Instructional Coach
 - Academic Inclusion Coach – Madeleine Leckie has been hired
 - Strategic Planning
 - Phase 1 is Completed, Phase 2 is in progress
 - Ms. Marie St. Fleur asked about how the plan would address an issue that came up in the strategic planning interviews, which was that the school was very strong in Arts but needed more focus on other subjects such as Science. There was discussion, during which Mr. Raul Garcia mentioned that he was concerned that the Humanities department retain its autonomy

- There was also some discussion about the impact of AI on curriculum. Ms. Sonia Alleyne gave the perspective on AI from her position at Suffolk University. Mr. Raul Garcia explained that there are very strict policies about the use of AI in his department. There was a broad discussion about the pros and cons of AI.
 - o Yonder Pouches will be implemented in SY25-26 – (Schools are using these to control cell phone use)
- **BTU Report**
 - o Ms. Nicole Mullen presented the overview
 - The BTU ratified a new contract
 - They negotiated an increase of 9% over 3 years with some teacher members receiving up to 11%
 - They centered lowest paid worker categories (e.g.: paraprofessionals)
 - There will be a couple of more half days for professional development
 - Inclusion Planning Teams
 - The planning team was discussed in the contract – added two family members
 - Composition: 5 Elected BTU members; 5 appointed positions; 2 family caregiver positions
 - Mr. Sutton explained this is a very important team and that they recommended the two new positions mentioned earlier
- **Family Council Report**
 - o Ms. Ayeesha Lane said Family Council has had a great year: Teacher Appreciation went well thanks to the members!
 - o Also, they gave away three \$750 scholarships to seniors
 - o Two senior parents will be leaving. There was a huge thank you to:
 - Ms. Stephanie Ruiz
 - Dr. Barbara Rodriguez
- **BAAF Report**
 - o Ms. Denella Clark gave the report:
 - She thanked Mr. Sutton and Mr. Bradley and the BAA staff
 - Some Board members are terming off – 11 new Board members will be joining
 - FY25 will be a record-breaking year – they have raised almost \$7 million; a record for BAAF
 - Campaign closing event will be on June 27th with Mayor Wu
 - Will continue with college scholarships this year
 - Ms. Clark asked for recommendations of a BAA alum to work with BAAF on tracking college scholarship recipients
 - Ms. Clark mentioned several summer events
 - October 23rd is BAA Honors - Melissa Manchester will open
 - Goal was to get the endowment to \$10 million. That has not been reached yet
- **Committee Reports**
 - o **Governance and Nominating Committee**
 - Dr. Banfield thanked Mr. Robert Chambers for his service as Board Chair (he will remain on the Board for one more year). And Ms. Myran Parker-Brass was thanked for her service on the Board and as Past Chair; gifts were presented
 - Ms. Alleyne presented the votes:
