- **Annual Title I Meeting**

Hilliard Horizon Elementary will take the following actions to conduct an annual meeting, at convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, parents' requirements, the school parent and family engagement policy, and the school-parent compact

- **Communications**

Hilliard Horizon Elementary will take the following actions to provide parents of participating children the following:

At Hilliard Horizon Elementary we use many methods of communication to connect with parents. Face-to-face, written correspondence, phone calls, Class Dojo messaging, and special invitations sent by Title I teachers. An interpreter is used to communicate with non-English speaking parents, and documents sent home are often translated into other languages.

Lauren Barkdull, principal of Hilliard Horizon Elementary states, "Communication and partnership with families is crucial to student success. We want to partner with all parents and guardians to support student growth and well-being. We look forward to any chance to partner with you! Title information and a list of calendar events is listed in this document."

- **School-Parent Compact**

Hilliard Horizon Elementary will take the following actions to jointly develop with parents of participating children - a school-parent compact that outlines how parents, the entire school staff and students will share the responsibility for improved student academic achievement and how the school and parents will build and develop a partnership to help children achieve the state's high standards.

As soon as students are assessed at Hilliard Horizon Elementary and a rank order student list of eligible students is created, the classroom teacher and/or the Title teacher will place a call to the parents to explain how Title services work. Parents are then informed of the upcoming Title I informational meeting. At this meeting a school-parent compact will be distributed to parents and a short presentation will follow that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement. Parents will be asked to return the compact (with the required signatures) to their child's Title reading teacher. Title teachers will follow up with parents who do not return them.

Lauren Barkdull, principal of Hilliard Horizon Elementary is aware that the Hilliard City School District is a district that is allocated \$500,000 or more in funding and must reserve 1 percent of their funding for parent and family engagement. Hilliard Horizon Elementary has an Arabic and Hispanic speaking staff member. Utilizing our staff, we are able to communicate with the majority of our parents. This helps develop a partnership with parents and promote a friendly and inclusive climate at the school.

Across the school, our priority is educating the whole child. We utilize the District Literacy Curriculum (Wit and Wisdom) and Math Curriculum (Illustrative Math) as strong academic foundations. Responsive Classroom and the Zones of Regulation are our community frameworks that give us the tools to positively connect and contribute to our community. We teach and positively acknowledge students Horizon SHINES expectations (Safe, Helpful, Inclusive, Nice, Engaged) as well as Hilliard’s Portrait of a Learner dispositions. We take time to reflect and emphasize building understanding of ourselves and empathy that can be extended to others.

Teachers at Hilliard Horizon Elementary communicate academic progress officially every twelve weeks at progress report time. Title teachers have a folder in which they send communication in written form to parents, which allows for parents to write back. Our staff members also use Class Dojo to encourage two-way communication with families. This is a great way for our teachers to keep parents informed about ongoing progress and is another way that teachers help parents understand how to work with their children at home.
