Marathon ISD is soliciting proposals for a Silent Panic Alert System. MISD is a single campus district with multiple instructional buildings.

Silent Panic Alert Technology Defined

Silent panic alert technology is defined as a silent system signal generated by the activation of a device, either manually or through software applications, intended to signal a life-threatening or emergency situation (such as an active shooter, intruder, or other emergency situation) requiring a response from law enforcement and/or other first responders. It may include 1) wired panic button or buttons, 2) wireless panic button or buttons, or 3) a mobile or computer application. (*Texas Education Agency – SPAT Grant*)

- Silent Panic Alert System to include main unit/transmitter with repeater
- 5 External Strobes
- 25 Panic Alert Buttons (classroom/desk placement)
- 17 Panic Alert Mushroom Buttons (hall, large room placement)
- 10 Lanyard/Carry Alert Button

Mobile and/or computer application (both preferred)

Installation Costs

Warranty

Maintenance/service contract options

Detailed listing of other related costs, i.e., travel

Functionality:

- Capable of being triggered manually by campus staff;
- Triggered automatically in the event a district employee calls 911 from any location within the school system;
- With any alert generated, the location of where the alert originated shall be included;
- The alert notifies a set of designated school administers as needed to provide confirmation of response, and if confirmed, notice is issued to law enforcement and emergency responder agencies of an emergency situation requiring a law enforcement and/or emergency response, and a notice can simultaneously be issued to all school staff of the need to follow appropriate emergency procedures
