# Spotswood Elementary School, Parent, and Family Engagement Policy

## **Statement of Purpose**

Spotswood Elementary School is committed to providing quality education programs and establishing high levels of performance for all children. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.

Provide parents of participating children—

Specifically, parents have the right to request the following information about each of their child's classroom teachers:
  - Whether the teacher has met state qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction.
  - Whether the teacher is teaching under emergency or other provisional status because of special circumstances.
  - Whether the teacher is teaching in the field of discipline of the certification or degree he/she received
  - Whether paraprofessionals provide services to your child and, if so, their qualifications.
- If the schoolwide program plan is not satisfactory to the parents of participating children, parents can submit any comments on the plan when the school makes the plan available to the district.
  - If there are any parental objections to this plan these concerns will be welcomed, a compromise will be reached with the parents, and the school plan will be adjusted accordingly.

# Part II: Shared Responsibilities for High Student Academic Achievement

As a component of the school-level Parent and Family Engagement policy, Spotswood shall jointly develop with parents for all children served under this part, a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement.

### Parent Responsibilities: Parents will support their children's learning in the following ways:

### **Student Responsibilities:** Students will share the responsibility for learning in the following ways:

- Always do my best and ask for help when I need it
- Read or listen to a book each day
- Complete work that is sent home by the teacher
- Bring my folder and backpack to school every day and give important papers to parents/guardians and my teacher every day
- Follow SES expectations
  - o Be Safe
  - Be Kind
  - Be Focused

#### School/Teacher Responsibilities: We as, Spotswood Elementary School staff, will:

- Provide Clear Communication through: Friday folders, newsletters, notes home, home visits, interim reports, report cards, phone calls, emails, and Parent/Teacher conferences
- Provide books for students to read or to be read aloud with students
- Provide opportunities for parents to learn how and what their children are being taught and opportunities for parents to volunteer
- Provide high quality differentiated instruction, by using HCPS curriculum and by following Virginia SOL's
- Send information translated as often as possible
- Provide frequent reports to parents on their child's progress.
- Provide parents with reasonable access to staff, opportunities to volunteer and participate in their child's class and observation of classroom activities.
- Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.
- Issue Report Cards every 9 weeks
- Provide Weekly Communication Folders
- Provide Home Visits when needed

- Communicate through emails, phone calls, text messages, and Seesaw
- Meet with the Parent Advisory Committee at least twice throughout the school year

The Parent/Teacher/Student Agreement is developed by PTO and reviewed annually. Revisions are made based on the Title I Survey results. The agreement is translated in Spanish and Arabic and other languages as necessitated by the percentage of speakers of other languages. It will be placed in the Parent School Handbook. It is also reviewed with parents at the fall Parent-Teacher Conference.

# **Building Capacity for Involvement**

Spotswood Elementary School will:

Provide information and assistance to parents regarding the state and local academic standards and assessments, how to monitor a child's progress, and work with educators. To ensure that parents are informed about academic standards and assessments Spotswood Elementary School will provide the following:

### Provide materials and training to parents;

Spotswood Elementary School offers training and materials to parents through the following events and activities:

Educate the academic community (teachers, specialized instructional personnel, and other staff) regarding the value of parent involvement, ways to communicate effectively with parents, and implementation of parent programs;

Spotswood Elementary School values and respects parent involvement in the school community. Through Heritage Nights and cultural awareness events, Spotswood welcomes and celebrates their diverse population. Interpreters are available at all events so that every parent can access the information shared. All written communication to the extent possible is translated in Spanish and Arabic and other languages as necessitated by the percentage of speakers of other languages. When situations occur involving students or the welfare of the entire school community, parents are always the first point of contact.

Provide opportunities for parent involvement activities requested by parents; Spotswood Elementary School has an open door policy for parents with both administration and staff. In addition, parents are encouraged to participate in the following activities:

Provide Title I funds for parent involvement activities;

• The Title I Coordinator allocates Title I funds to Spotswood to be used for Parent Involvement. These funds are used for all parent activities, i.e., Literacy Nights, CAC meetings, and Materials for parent workshops.

Establish a school and division Community Advisory Council;

The school's Home School Liaison/Title I Parent Coordinator will contact each classroom teacher and the school principal to provide recommendations for parents to serve on the CAC.
