Terms and Conditions

General

- By commissioning me, you agree to the following terms and conditions
- I have the right to decline any commission without reason or explanation
- I have the right to change my terms of service at any time
 - Altered terms will not apply to past commissions, or commissions begun on previous terms
- All commissions are digital files, and will be distributed to the commissioner by the agreed method (email, discord, AO3 publication, etc)
- Unless otherwise stated, all times, dates, and prices when discussing are New Zealand based (NZDT timezone, the NZ dollar)

Commissioning

- Prices are listed below
- Any prices outside of the list will be negotiated per commission based on complexity, predicted time commitment, and the commissioner's wishes
- I do not accept reservations and do not have a waiting list
- When providing me with references, you must ensure you have full permission for usage of original content as depicted by the references

Payment

- All international payments must be through paypal
- Payment dates will be arranged per commissioner throughout the process of the commission, however failure to pay within 7 days unless agreed otherwise will result in a termination of the commission
- I have the right to change my rates at any time without reason or explanation
 - Altered rates will not affect commissions begun on previous rates
- If the commissioner wants to cancel the commission, deposits will be nonrefundable if I have begun the commission
- If I cancel the commission, all deposits will be refunded

Creation Process

- Order of commissioning does not reflect the order of work
- All commissions will receive at least one opportunity for review and minor revisions. Revisions outside of the pre stated opportunities will be conducted upon my terms
- Progress reports will come at key stages, or when requested by commissioner
- Deadlines can be negotiated at time of commissioning, and will affect pricing on a case by case basis

- Major changes and/or additions can be negotiated throughout creation process, though can be refused and may be subject to additional costs

Rights

- I retain all rights to my creative works, with the right to repost, republish, and use and sell my artworks. Profit will not be shared
- Reposting of artwork is permitted with my watermark included and sufficient credit
- Commissioner may not make profit off a commissioned piece unless negotiated at the time of commissioning, subject to increased prices
- Republishing of writing works may be negotiated, however is not permitted without negotiations
- I claim no rights to characters or other intellectual property used while creating a commission

- Description must contain all plot points, relevant details, and other information you want in the finished piece
- The less information offered, the more creative liberty I will take, within keeping to what I am given
- Reference material in form of images or short descriptions required for key characters and locations UNLESS you wish to give me creative freedom
- Total word count (this will NOT include the outline) recommended to be supplied, however can be negotiated if necessary

Payment Process

- Initial deposit of $\frac{1}{3}$ total quoted payment after which planning will begin
- Second deposit of $\frac{1}{3}$ total quoted payment after which drafting will begin
- Final deposit of $\frac{1}{3}$ total quoted payment upon which finished commission will be sent UNLESS there is a **word count extension negotiation**
 - If such negotiation occurs, a penultimate deposit to bring **original quoted payment** to 90% will be required before reviewing the extensions
 - If extension discarded, final deposit not required until edits have been made

Creation Process

- After receiving initial deposit, an outline will be worked and sent to commissioner for revisions
- Upon the second deposit and go ahead from commissioner, piece will be drafted and edited
- Additional progress reports available at commissioner's direct request
- Additional reviews will happen at my discretion
- Final piece will be sent on receiving full payment
- Major changes outside of reviews will be discussed and approved, and may be subject to additional cost depending on complexity
