b. Brackley Lane

- There was a meeting with most of the track / field owners and members of the Parish Council, Josh the land owner and Berrys - the issues discussed were - what was happening with the track and ownership and what was happening in the field
- Berrys enlisted a contractor to lay a hard surface on the track without landowners permission. The owners wrote to Berrys and asked them to reinstate the track and the track was closed by WNC due it being unsafe
- Another email was received from Berrys which said Josh the owner of the field still wanted to progress with the track completing the laying of the hard surface
- The owners would like the track to be put back as it was as there was nothing wrong with it.
 There was no communication from the Josh the field owner or Berrys to the land owners and there is now lack of trust with Berrys
- Highways can only advise what surface needs to be on the track, they cannot agree if it is laid or not, only the landowners
- Landowners to go back to Tom Harris and Berrys that they want to inform them again that they want the track reinstated to the original condition
- Parish Council to speak to Katie Angle from WNC Highways to find out what will happen if the track is not reinstated
