PRIVACY POLICY

This Privacy Policy of "ORIENTEER" LLC (further named as "Policy") has been developed in accordance with the requirements of the existing legislation and determines the protecting procedure of User's personal data collected via the following websites available on the Internet at the following URL: https://ex.events/ and https://ex.events/<a href="https://ex.

"ORIENTEER" LLC ensures complete observance of the rights and freedoms of Users in the course of personal data processing, including protection of right to personal and family privacy.

Using the services of the websites means unconditional acceptance by User of the hereby Policy along with all of the terms of processing the User's personal information; in case of disagreement with these conditions, the User shall refrain from using the services.

This Privacy Policy deals with the whole information which "ORIENTEER" LLC may get about the User during his or her use of the websites, its services, utilities, software and products possessed by "ORIENTEER" LLC. "ORIENTEER" LLC does not control and is not responsible for third-party websites to which the User can click on the links available on the Operator's websites.

1. TERMS AND DEFINITIONS USED IN THIS POLICY

- 1.1. User's personal data means and goes for:
 - Any personal information User provides about oneself on his own while using the websites. Any other information is provided by the User.
 - The data is automatically provided to the websites services in progress of their being used by means of the software previously installed on User's device, including IP-address, cookie files data, data of User's browser (or any other software which accessing the Services is performed by), details of the equipment and software specifications utilized by User, date and time of accessing the Services, URL's of the requested pages and any other detailed information of the kind.
- 1.2. User is any individual who has voluntarily proceeded with the registration and/or has used the websites, utilities, software and products by "ORIENTEER" LLC.
- 1.3. Personal data operator is "ORIENTEER" Limited Liability Company located as a legal entity at the following mail address: 14205 SE 36TH ST STE 100, BELLEVUE, WA, 98006-1553,

- 1.4. Cross-border transfer of personal data transfer of personal data to recipients are found on the territory of a foreign state, or to a foreign individual or foreign legal entity.
- 1.5. Destruction of personal data the process of rendering personal data inaccessible, irretrievable and unusable for any person.

2. GENERAL PROVISIONS

- 2.1 Personal data provided by the User and allowed by the User to be processed under this Privacy Policy includes:
 - Surname, name of the legal representative;
 - Legal representative's contact information: mobile phone number, e-mail address, registration address at the place of residence;
 - Surname, name, of a child;
 - Grade of study in accordance with the system of secondary general education.
- 2.2. Also "ORIENTEER" LLC collects and processes the data which is automatically provided to the Website Services in progress of their use by means of the software previously installed on User's device, including IP-address, cookie files data, data of User's browser (or any other software which accessing the Services is performed by), details of the equipment and software specifications utilized by User, date and time of accessing the Services, URL's of the requested pages and any other detailed information of the kind.
- 2.3. Information about the User's IP-addresses by the Operator exclusively to identify and eliminate technical problems.
- 2.4. The content and volume of the processed Personal Data correspond to the purposes of processing established in the Personal Data Processing Policy.
- 2.5. All User's Personal Data refers to confidential information.
- 2.6. The Operator has the right to collect, systematize, accumulate, store, clarify (update, change), use, depersonalize, block, destroy, process using the main methods of such processing (storage, recording on electronic media and their storage, compilation of lists).
- 2.7. The processing and storage of User's Personal Data is carried out without any time limit in any legal way, including in personal data information systems using automation tools or without using such tools. The processing of personal data of Users is carried out in accordance with Data Protection Act 199.

3. TERMS OF PROCESSING THE USER'S PERSONAL DATA AND ITS TRANSFERS TO THE THIRD PARTIES

- 3.1. The Operator maintains the confidentiality of the User's personal data, except in cases where the User voluntarily provides information about himself for general access to an unlimited number of persons.
- 3.2. "ORIENTEER" LLC keeps the right to transfer User's personal data to third parties in the following cases:
 - 3.2.1. User has clearly expressed its agreement to these actions.
 - 3.2.2. The transfer is necessary for specific service to be utilized by User, or in order to complete performing certain agreement or contract signed with that particular User.
 - 3.2.3. The Operator received an official request from state bodies, local authorities, law enforcement to provide the User's personal data.
- 3.3. The right to access the User's personal data, which does not require a separate consent of the User to process personal data, is granted to the executive body of "ORIENTEER" LLC, as well as to employees of the company and other involved persons directly related to the activities of "ORIENTEER" LLC on the conduct and

organization of web games.

3.4. The Operator warns the persons who have received the User's personal data, including the Operator's employees, to use User's Personal Data only for the purposes for which Personal Data is received, and requires these persons to confirm that this rule has been observed. Persons who have received the User's Personal Data are required to provide confidentiality of Personal Data.

4. RESPONSIBILITY

- 4.1. The Operator takes the necessary organizational and technical measures to protect the User's Personal Data from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties.
- 4.2. In case of loss or disclosure of Personal Data, the Operator informs the User about the fact of loss or disclosure, and together with the User takes all necessary measures to prevent losses or other negative consequences caused by the loss or disclosure of the User's Personal Data.
- 4.3. The Operator blocks Personal Data related to the relevant User in case of request from the User or his legal representative or a Notified Body for the period of verification in case of revealing inaccurate personal data or illegal actions.
- 4.4. The Operator carries out the destruction of Personal Data related to the relevant User in case of request from the User or his legal representative or a Notified Body.
- 4.5. The Operator bears responsibility for guilty actions related to the disclosure of confidential information in accordance with the legislation of and undertakes to reimburse the documented losses incurred by the User in connection with the unlawful use of personal data.
- 4.6. In case of loss or disclosure of the confidential personal information, the "EO" LLC shall not be responsible if the confidential personal information:
 - 4.6.1. became available to the public before its loss or disclosure.
 - 4.6.2. was disclosed at the User's consent.

5. RESOLVING THE DISPUTES

- 5.1. Before applying to the court with a sue on disputes arising from interaction between the User and "ORIENTEER" LLC, filing a claim (a written proposal to voluntarily resolve a dispute) is obligatory. A scanned copy of the claim can be sent by following e-mail addresses: office@eo.events, the original claim should be sent by a Post Office or courier service. The date of receipt of a claim is considered the date of receipt of a post mail.
- 5.2. Within 10 (Ten) calendar days since the date of receiving the claim, its recipient notifies the claim applicant in a written form of the considered results on reviewing the claim.
- 5.3. In case agreement is not reached on a claim, its relevant dispute shall be referred to the Court at ""ORIENTEER" LLC location.
