We harness the best expertise, experience and evidence on resilience and accelerate learning across institutions, practitioners, policies and geographies. For example, GRP with SouthSouthNorth (SSN) and the International Centre for Climate Change and Development (ICCCAD) lead both the Resilience Knowledge Coalition that promotes Global South expertise and the Voices from the Frontline (VFL) Initiative facilitating the sharing of grassroots communities' stories on resilience. GRP builds networks and leverages opportunities for policy engagement and investment brokering, ensuring that the most vulnerable are at the centre of decision-making.

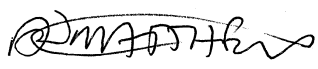

Principle Number	Detail of Implementation
2,5 and 7	GRP is co-creating a Resilience Knowledge Coalition together with co-leads SSN/ICCCAD and will ensure that global South demand and expertise take center stage. In addition, GRP supports Voices from the Frontline (VFL), a joint initiative by ICCCAD and CDKN to support grassroots communities in sharing their stories on the challenges of and the responses to the COVID-19 pandemic.
1, 4 and 5	GRP is supporting a series of South to South resilience academies that support Southern thought leaders to coordinate and develops solutions to local adaptation and resilience challenges.
8 and 7	GRP builds networks and leverages opportunities for policy engagement and investment brokering, ensuring that the most vulnerable are at the center of the dialogue. Examples: engaging the communities from the Global South into consultation process of common Resilience Narrative under MPGCA; explicitly targeting grassroots federations and CBOs and making space for them in the consultation processes (Regional Resilience Dialogues) run together with the High Level Champions to include

	their context-based/region-specific experience into consideration for Race to Resilience; Ensuring digital inclusion (interpretation services at events and Zoom subscriptions to place CBOs as initiators vs 'recipients' of dialogues); doing things differently by including culturally recognized forms of engagement (e.g., drama/signing performance at COP25 as an example of how community consultations are rendered more participatory in many rural areas around Africa).
