#Firearm Owners Protection Act

This is an act to expand the second amendment rights of Greater Appalachians

- *Whereas, the second amendment of the US Constitution is under siege by Liberals and Republicans*
- *Whereas, the right to bear arms should not be infringed*
- *Whereas, Greater Appalachia has a long and respected gun culture*
- *Whereas, The firearm industry has produced thousands of jobs in the United States*
- *Whereas, It is the government's job to protect the rights of Americans*
- *THEREFORE, BE IT ENACTED by the General Assembly of the Commonwealth of Greater Appalachia that:*
- **Section 1. Title**
- (1) This bill shall be referred to as the "Firearm Owners Protection Act" or "GAFOPA"
- **Section 2. Repeal of Gun Control**

^{**}Section 3. Protection For Gun Owners**

- (1) It shall be unlawful for any Greater Appalachia law enforcement officer to initiate a traffic stop, initiate a public search, or search or enter any permanent or temporary residence on the basis of observing any individual's mere possession of a firearm unless such law enforcement officer has witnessed the commission of a crime by any person the officer intends to stop, search, or whose home the officer seeks to search or enter.
- (a) Any evidence obtained through such a stop, search, or entry shall be inadmissible in a court of law.
- (2) The Commonwealth of Greater Appalachia shall not infringe upon the rights to own, possess, and use a gun otherwise in accordance with the law on the basis of an individual's use or prior conviction for possession of marijuana.
- (3) The Commonwealth of Greater Appalachia shall not infringe upon the rights of any individual to produce, manufacture, carry, possess, or own any non-metallic firearm including any firearm produced through 3-d printing.
- (4) Any individual who may legally possess a firearm, openly or in a concealed fashion, may also possess any quantity of ammunition, bumpstocks, silencers, mufflers, modular parts, or other components or accessories for a firearm.

Section 4. Gun Ownership Day

(1) June 26th shall be known and celebrated as "Gun Ownership Day" to celebrate the Second Amendment and Gun Ownership.

Section 5. State Firearm

(1) The official state firearm of Greater Appalachia shall be the Kentucky Rifle, also known as the American longrifle.

Section 6. Enactment

- (1) This act shall go into effect immediately after it is signed into law.
- (2) If any portion of this act is struck down, the rest of the act shall still be in effect.
