"Substantial questions would arise if the courts were to begin saying what means of speech should be preferred or disfavored." --point being that with changing technologies, how could there be government oversight/regulation of campaign messaging? more: "We must decline to draw, and then redraw, lines based on the particular media or technology used to disseminate political speech from a particular speaker."


