

# Privacy Policy

### 3. Content & Media

- **Uploaded or Imported Videos:** We may store or process videos you import from TikTok, Instagram Reels, or other sources. This content is used strictly within the scope of our App’s functionalities.

## 2. How We Use Your Information

We use your information to:

### 1. Operate and Improve the App:

- Provide and maintain core shoppable video functionality.
- Diagnose technical issues and optimize user experience.

### 2. Communicate with You:

- Respond to inquiries, send support or maintenance messages.
  - Provide updates on new features or policy changes.
- 3. Enhance Security:**
- Monitor and analyze usage and activities in relation to the App for security purposes.
  - Detect and prevent fraudulent transactions or unauthorized access.
- 4. Comply with Legal Obligations:**
- Fulfill any applicable legal or regulatory requirements.

### **3. Data Sharing and Disclosure**

We do not sell or rent your personal information. However, we may share your information under these circumstances:

- 1. Service Providers:**

- 2. Business Transfers:**
