December 12, 2018 Board Minutes

The board meeting of the HLV Community School District was held on December 12, 2018, at 5:00 p.m. President Hollopeter called the meeting to order.

Hawkins motioned to approve the quote for new furniture for Mrs. Lender's elementary classroom, seconded by Blomme, unanimously adopted.

Under item 2.7, Lisa Haverkamp and Kris Donnelly gave a presentation of the services offered to the District by Grant Wood.

Under the Superintendent's report, Hohensee presented his December schedule. Hohensee commented the IASB convention was very good. He made contact with several vendors to assist with several projects we have. Day on the Hill is scheduled for February 5, 2019. A reminder the Area School Board Inservice will be held January 31, 2019 at 6:00 pm at the Michael J. Manatt Community Center. The food bank was open for the first time on December 6.

Principal Lahndorf reported he attended the Mental Health and Safety conference recently, which was a great conference.

Guidance Counselor Robison noted she has been working on ASFAB and the webinar on Iowa Assessments.
