

# TERMS OF SERVICE

---

Welcome to the Terms of Service for Crayon's commission.

Please read these terms and conditions carefully before using my commission's services.

Purchasing means that customers have read and agreed to the terms and conditions.

## 1. GENERAL TERMS

- I didn't accept commissions that consist of **NSFW, Mecha, Anthro, Bara, Gore, and Heavy Detailed Background**. However, there's toleration for **horror-themed art and blood splatter**.
- I have the right to refuse any order that is not in my expertise and one that I'm not comfortable with.
- Art will include a watermark that **customers are not allowed to remove**.
- Maximum revisions is 2 times, if it feels like there's more revisions needed the next revisions will be charged. See point 2.1 and 2.2 for details.

## 2. PAYMENT AND PRICES

### 2.1 PAYMENT

- Currency accepted are either **INDONESIA RUPIAH** for local purchases, and **USD** for international purchases.
- First payment has to be paid after the sketch has been sent by 50% from the total price. The payment's deadline is 3 days after the sketch has been sent.
- Last payment has to be paid after the final product has been sent by the amount of price left, or another 50% from the total price.
- Payment can be paid through: **BCA, Gopay, Shopeepay**, or **Trakteer** for local purchases, and **Paypal, ko-fi**, or **V-Gen** for international purchases.
- By payment with **Paypal**, I will send an invoice to the customers to prevent chargeback. Customers would likely be asked for an email in order to create an invoice.
- There will be extra charge for following conditions: commercial usage, streaming usage, extra revisions, heavy details on clothes.

### 2.2 PRICES

- Initial prices are below:

- Additional Prices and Extra Charge:
  - No extra charge for personal usage.
  - For commercial usage, the price will be increased by +80% from the initial price.
  - For streaming usage, the price will be increased by +20% from the initial price.
  - Additional character +20%
  - Extra revisions will be charged for 50k IDR or 10\$ USD.
  - Heavy details on clothes will be charged for 50k IDR or 10\$ USD.

### **3. PROCESS AND DELIVERY**

#### **3.1 PROCESS**

- I will notify the customers when I have started your commission.
- Commission will take 3-8 days.
- I will send the customers the work progress. (Sketch, base color, half-rendered, finished product.)
- If anything comes up that could affect the duration to create the commission, I will tell the customers as soon as possible.
- Revisions may affect the timeline.

#### **3.2 DELIVERY**

- As stated in point 3.1, the products would take 3-8 days to create.
- I will send the finished product by .PNG files and will be uploaded first through Google Drive. Customers then would receive the link.

### **4. COPYRIGHT, LICENSING, AND USAGE POLICY**

- **All rights reserved to the artist**, Crayon (@babbidib00)  
Therefore, customers are not allowed to:
  - Reproducing/using the copyrighted artwork for commercial purposes unless there's any agreement beforehand. (e.g commercial/streaming purposes commission)
  - Claiming the artwork as no other than the creator.
  - Removing my watermark/any signature from the artwork.
  - Altering the artwork without the creator's consent.
  - Using my artwork for AI training.
  - Using my artwork for NFT.
- However, customers are allowed to:
  - Use the artwork for personal purposes. (If customers want to upload the artwork, credits are required.)
  - Print the artwork for personal purposes.
  - For commercial type commission, customers are allowed to use the artwork for any monetized instances, or selling or reselling Work to another party, as a part of any product, or on another platform.

### **5. CUSTOMER SATISFACTORY AND COMMUNICATION**

- Customers' satisfaction will be prioritized, and I will strive to perform for the best.
- I would not upload the finished products without the customers' consent.

- Ongoing communication would occur through the work progress, so let's have a harmonious communication.
- Communication channels include: Discord, Twitter DM, Instagram DM, Bluesky DM, V-Gen DM.

## **6. REFUNDS AND CANCELLATION**

- As stated in point 3.1, I will notify you when I have started your commission. Therefore, customers will lose the right to cancel.
- If I, due to any reasons, are unable to start the commission, customers have the right to cancel.
- Customers are not allowed to refund.
- If after the first payment customers decide to cancel the commissions, there will be no refund.
