Arm in Arm is “Exposing the Unspoken”

Arm in Arm and The People’s Justice Council have released a new documentary that takes us behind the scenes of their Power 4 Southern People NOT Southern Company campaign.

Birmingham, AL - Over the last four years, Arm in Arm (AiA) has forged strategic alliances throughout the United States, concentrating on Southern Company (SoCo) and its subsidiaries - Mississippi Power, Alabama Power, and Georgia Power - and their influence within their respective states. **Premiering on January 25, 2025**, “*Exposing the Unspoken*” offers insight into the evolution of AiA’s movement and the expansion of their coalition across the Southeast and beyond.

Produced by Arm in Arm and The People’s Justice Council, the documentary chronicles the stories of individuals and communities impacted by Southern Company's unfair billing and predatory practices. It underscores AiA’s commitment to holding this powerful platform monopoly accountable for its harmful practices and the damage it inflicts on our environment.
