Abstract: The records of the Coalition of Feminist Scholars in the History of Rhetoric and Composition are primarily administrative, including correspondence, meeting minutes, social media posts, Feminisms and Rhetorics Conference planning, photographs, and videos.

Language: The material is in English.

Access and Use

Acquisition Information: With few exceptions, these records were created by the CWSHRC and CFSHRC. Future additions to the records are expected.

Access Restrictions: The record group is open to research unless otherwise noted. Restricted folders include: some correspondence; 501c3 status; forms and templates.

Copyright: Copyright remains with the Coalition of Feminist Scholars in the History of Rhetoric and Composition.

Background Information

Collection History: The CWSHRC was founded in 1989-1990, but did not begin officially constructing a digital archive of key administrative documents for its officers and members until summer 2013, under the guidance of Tarez Samra Graban and Nancy A. Myers. In spring 2014, Graban assumed the role of interim Archivist and Historian, working with the Coalition's first web coordinator, Alli Crandell, to develop an organizational schema for an open-access WordPress archive that would align with the launching of the new Coalition website. Between 2014 and 2016, the archive remained administrative but dynamic, folding in additional materials such as social media posts, photographs, and videos. In 2016, the organization changed its name to CFSHRC, and the position of Archivist and Historian was created with Alexis E. Ramsey-Tobienne filling the role. In 2018, due to diminishing use of the online archive and residual challenges of WordPress maintenance, the decision was made to discontinue open-access and relocate the archive to a DropBox repository where it could better serve both the organization's preservation and its growth. Because the archive was first born-digital and constructed in a web-based format, it was organized on the basis of referential tags rather than by static folders. For that reason, most documents were cross-referenced and named first by *material genre*, then by *date*, and then by *author_recipient_topic*.

Scope and Content

The records of the Coalition of Feminist Scholars in the History of Rhetoric and Composition (CFSHRC) include correspondence, events files, meeting minutes, photographs, social media posts, and video. The strength of the collection is found with the correspondence, meeting minutes, Feminisms and Rhetorics Conference planning materials, and social media posts. There are also two videos that capture the CFSHRC's history at two moments in 2008 and 2014. The records were created by various officers and members of the Coalition including, but not limited to, past presidents of the Coalition, the editors of *Peitho* journal, Executive and Advisory Board members, and task force volunteers. Most files are first organized by material genre and then sorted by date; thus, the finding aid reflects that organizational pattern.

NB: the archive still being populated through 2019.

The *Annual Meetings* series ranges from 1999-2019 and includes meeting agendas, motions and votes, task force proposals, and task force reports arranged by year and by conference. Of particular prominence are the 2005 *Peitho* Development Plan; the plans for converting *Peitho* to a peer reviewed journal in 2013; planning documents for the 25th Anniversary Gala in 2014; and the contracting of Alexandra Hidalgo's 25th anniversary documentary "Lifting As We Climb."

501c3 Status – Access Restricted

The *501c3 Status* series ranges from 2006-2016 and contains legal documents and correspondence related to the non-profit, tax-exempt status of the organization.
