Privacy Policy

This privacy policy describes information gathering and dissemination practices for all mobile applications that were created by King Status Apps ("we," "us" or "our") through our mobile and web applications and how we use that information.

Crash log Data

Except that we collect only the app crash logs to improve the stability of the game. We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information (through third-party products) on your phone called Crash data logs. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.

Cookies

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.

This Service does not use these "cookies" explicitly. However, the app may use third-party code and libraries that use "cookies" to collect information and improve their services.
