Populations of focus include prevention strategies for Adult Heavy Drinking (Ages 25-65), Youth Cannabis Use (Ages 12-20), and Problem Gambling (Ages 12-20). What has been proposed for strategies, and are currently planning and building connections for: Prime for Life EB curriculum for Adult Healthcare workers in the county, low risk choices to encourage healthy lifestyle choices.

Just finished a Love Notes implementation at the Storm Lake High School. Currently have a teen parents group meeting every Wednesday. There are 4 teen moms and 1 teen dad that usually attend. Two are sophomore and three are seniors. It is Talk-Tober month. I have sent Annette the flier to be shared with

		everyone. It has a QR code that takes parents to the PCIA Website and gives them tips on how to talk to their teen about healthy relationships. It also has a question of the day for the month of October to encourage that parent/child communication
Autumn Hartman	Rosecrance Jackson Centers	The State Opioid Response (SOR) Grant just entered its third year at the beginning of October. Our goal this fiscal year is to reach out to more schools about Naloxone. Naloxone is the opioid overdose reversal drug. While we hope schools never have to use it, it is better to be prepared. I can provide the training on how to look for overdose signs and how to administer Naloxone. I also share a document from the lowa Department of Health and Human services on how to order Naloxone for schools and businesses.
		Aside from Naloxone trainings I do provide classes on Substance Abuse 101, Harm Reduction, Trauma Informed Care, Stigma Associated with Substance Use, and the basics about opioids and stimulants.
