

After-Prom 2023 Release From Liability

This is an important legal document. Please read it carefully. Do not sign it unless you have read it, you understand it, and you agree with all its terms.

In consideration of their willingness to allow my child or children (named below) to attend the After-Prom party sponsored by the After-Prom Party Committee ("Committee") on April 8, 2023. I hereby forever release the Committee, its members, agents, employees, assigns and successors, from any liability on any claims of any kind whatsoever arising in any way out of my or my child's participation in any After-Prom activity sponsored by them. This release is intended to be the broadest possible release allowed by law. It includes, but is not limited to, strict liability claims, contract claims (express or implied), warranty claims, tort claims whether based on common law or any statute or regulation. It also includes any and all claims for injuries or damages sustained by my child during or in connection with my child's participation in the activity which are alleged to have been sustained, in whole or part, as a result of the negligence of one or more persons protected by this release.

I understand that the Committee will provide space and activities for my child to participate in during the After-Prom party. I understand that transportation of my child is not the responsibility of the Committee. I understand that state law prohibits any child under the age of 18 from driving a motor vehicle between 12am and 5am, and that if my child leaves the After-Prom party during those hours, whether on his/her own or as a result of my instructions, he/she does so at his own risk and the Committee has no legal power or duty to stop him/her. I understand that once my child leaves the After-Prom party, he/she will not be allowed back in.

I represent that I (and/or) the children named below are in good health and that I (the children named below) do not have any physical or mental conditions which might affect their ability to participate in the After-Prom party. (If any child covered by this release has one or more such conditions, please list them here. The information will be kept confidential.)

In the event of a medical emergency I authorize any member of the Committee or volunteer for the After-Prom party to seek medical assistance for my child. In the event of such emergency the Committee will attempt to contact the undersigned parent/guardian at the phone number below.

This release shall be binding on all my child, heirs, agents, assigned, and on any other person(s) who might otherwise be entitled to file suit on my behalf or on behalf of my child.

If a student leaves the After-Prom party without After-Prom volunteer knowledge, the parent volunteers are not liable, or responsible for anything that happens thereafter involving the student, regardless of the student's age.

If a student leaves the After-Prom party without parental or guardian permission, the volunteers are not liable or responsible for anything that happens thereafter involving the student, regardless of the student's age.

If a student is visibly impaired or suspected of being impaired at the event, an After-Prom point person will call a parent/guardian, or the police at their discretion (e.g., if unable to reach parent/guardian, if student is uncooperative, found with drugs/alcohol, or for safety reasons).

Students shall be respectful to the UMC staff and parent volunteers running the After-Prom party.
