Equity Survey Results


Results from Diversity, Equity, Inclusion & Belonging Readiness Survey we asked all group members to take in February:

14 responses, which we reviewed

- Respondents were mix of nonprofit & govt
- Mix of administrative leadership, trails planners & other types
- Overall high to moderate level of familiarity and comfort with Diversity, Equity, Inclusion & Belonging definitions, discussions and are doing DEIB work in their own orgs.

What topics involving DEIB work do you have the strongest interest in learning more about, particularly through the lens of trails work?

We will do some thinking on the above answer.

We're still planning a workshop, hopefully for the August session, in which take the universal definitions of diversity, equity, inclusion and belonging — break into small groups – and rewrite them to apply specifically to trails work.

Group reflections:

- We need a consistent, measurable way to identify access gaps in our water trails.
- Trail desert in NE near Rocky Butte
- Let's think in terms of gaps. Identify, prioritize and highlight them.
 - Lack of I-84 bike path connection to I-205 bike pathway

- A future presentation on the upcoming Clark Co/SW WA trail updates would be a good follow up to this convo, to see future trail opportunities up there.
- Desire to include entire Coast to Gorge Trail
- There could be a somewhat "quick and easy" update to the 2010 plan keeping those trails, adding a few key potential regional trails and discussing the challenges to creating these trails.
 - And maybe adding in Max's maps with discussion of what's been built.
- Feature difficult issues with railroads
- Budget & funding mechanisms so different in Oregon and Washington sides. Is reviving this plan helpful in the Interstate Bridge Replacement project strategy?
