The state of funding change: How should we act, and how should we be together?

To kick off this year's conference, we will explore the scale of the transition that's needed and philanthropy's role in shaping responses to today's crises. As humanity moves through multiple self-inflicted crises, honest conversations are required for a radically different approach. While some foundations struggle with their colonial legacies and defensiveness, risking further harm by freezing resources, others remain confident in their wealth and strategies. However, both sides fail to address crucial questions: How can we repair harm and heal relationships? How do we learn the lessons of the harms we have done so that we can embrace the ambition, plurality and complexity that this moment demands of us?

## The ethics of investing

Join us as we dive into some of the fundamental assumptions that underpin investing today. We will examine a broad spectrum of what is considered ethical and responsible to impact investing from within the industry and explore how investors can engage more deeply with questions of ethics. Speakers will address the challenges that emerge when looking at the fundamentals of investing today and the worlds we hope to see flourish and seek to move towards. Why are risks often shifted to investees, usually worse positioned to absorb these risks? What does return mean when investing for impact, if investees can invest their profits to create more impact rather than returning to investors? We will examine emerging practices in the field that offer glimpses of hope and draw lessons from them regarding the values and principles that should guide ethical investment practices. This session aims to highlight pathways toward more aligned and impactful investment strategies.

“Reimagining Investment Structures” is a series of animated videos about the need to improve investment structures so that investors can align their internal investment governance and financial analysis practices with the principles of system-level investing and Universal Ownership. Part one focuses on the issue of inequality and how workers have lost economic power due to the “labor squeeze.” Part two focuses on risks relating to existing investment structures, such as leveraged buyout strategies used by some private equity firms. Part three looks at the role that investors—particularly Universal Owners—can play in building a better financial system by taking into account issues like fund manager compensation, financial engineering, and tax structures.

## The psychology of wealth and the challenges when giving it up

In this session we will explore the concept of 'enough' in regards to personal wealth and how our relationships to wealth and the culture around it affects those in proximity to it. How does one determine a level of 'enoughness', by which factors will this be influenced and how might an understanding of 'enough' change over time – especially when embarking to redistribute personal wealth? A psychology of wealth might also be informed by shifting narratives around wealth in society and by the views of those working closely with wealth holders (wealth advisors, investment managers, accountants, lawyers etc.). We will delve into some of the emotional barriers experienced by wealth holders and the people

around them when embarking on journeys of wealth redistribution and discuss practices for shifting from a scarcity mindset to one of abundance. By zooming into the underlying wiring and mindsets that shape our relationships with wealth, money, and power, we will open up a space for alternative perspectives and approaches to support individual transformative action.
