RCUSA Communications Working Group Toolkit for Media Response to FY18 Presidential Determination

In light of President Trump announcing a refugee resettlement cap that is the lowest in U.S. history, RCUSA has prepared a multifaceted response for member organizations to help amplify a counter-narrative both at the national level and to share with their constituents across the country. The administration must be held accountable at a time when the world is facing the largest refugee crisis in recorded history, with over 22 million registered refugees, half of whom are children. We ask: how could our country abdicate our leadership role for this critical, life-saving humanitarian program? ACTION ALERT: Urgent Call to Increase the U.S. Refugee Admissions Goal!

Background: The Administration has now released their refugee admissions goal (officially known as the Presidential Determination), and it is the lowest in U.S. history. At a time when the world is facing the largest refugee crisis in recorded history, with over 22 million registered refugees, half of whom are children, how could our country abdicate our leadership role for this critical, life-saving humanitarian program? This decision means vulnerable refugees, including those who served our country in Iraq, torture survivors, unaccompanied refugee children, those with severe medical needs, and persecuted religious minorities, will be left in harm's way. This decision could needlessly push them into the hands of traffickers or worse. To do less means loss of life, deepening regional and global instability, and families torn apart.

We know that the United States is capable of doing far, far more – that's why WE NEED YOU to tell your members of Congress AND the President that you strongly support an admissions goal of at least 75,000 individuals being protected and welcomed in the coming fiscal year. Let's push the President and Congress to do what we know we're capable of.

Sample Script:

"I'm your constituent from (CITY/STATE), and I am calling to express my deep disappointment that the President set the lowest refugee admissions ceiling since the start of the U.S. refugee program. I urge (Member's Name) to publicly call on the President to raise the admissions ceiling for this year to 75,000, and to join other members of Congress in finding ways to encourage the President to do this. The world is experiencing the worst global displacement crisis in history – with over 22 million refugees, half of whom are children. How could we decrease our commitment to helping those in desperate need at such a moment? My community welcomes refugees, and wants to help them – I encourage (Member's Name) to stand up for what is right, and protect this life-saving humanitarian program."

If you feel comfortable, share a personal story about why helping and welcoming refugees is important to you (your faith, your community, your business, your family or background etc.) Let them know the specific ways that refugees benefit and are welcomed into your community, and why refugee protection is so important to you. Make it personal!
