Senate District 36 – No Quorum

Due to the vacancy in the Senate District, a Special Election has been scheduled for the 36th Senate District. The Special Primary Election Primary will be held on Tuesday, February 25, 2025.

Assembly District 32 – Endorsed Chris Cruz-Boone

Due to the vacancy in the Assembly District, a Special Election has been scheduled for the 32nd Assembly District. The Special Primary Election Primary will be held on Tuesday, February 25, 2025.

Congressional District 20 – No Quorum

Due to the resignation of Representative Kevin McCarthy, a Special Election has been scheduled for the 20th Congressional District. The Special Primary Election Primary will be held on Tuesday, March 19, 2024.

Assembly District 62 Special Endorsing Caucus Information

No Special Caucus was scheduled in this district prior to the State Party Endorsement Submission deadline. There is no endorsed Democratic candidate to the April 5, 2022 Special Primary Election.

Congressional District 22 – Endorsed Lourin Hubbard

Due to the resignation of Congressman Devin Nunes, a Special Election was held for the 22nd Congressional District on Tuesday, April 5, 2022. No candidate achieved the requisite votes. Per the CDP Bylaws, we have endorsed the only Democrat advancing to the Special General Election held on June 7, 2022.

Assembly District 17 – No Consensus

Due to the resignation of Assemblyman David Chiu, a Special Election has been scheduled for the 17th Assembly District. The Special Election General will be held on Tuesday, April 19, 2022.

Assembly District 80 – Endorsed Georgette Gomez

Due to the resignation of Assemblywoman Lorena Gonzalez, a Special Election has been scheduled for the 80th Assembly District. The Special Election Primary will be held on Tuesday, April 5, 2022.

Assembly District 11 – Endorsed Lori Wilson

Due to the resignation of Assemblymember Jim Frazier, a Special Election has been scheduled for the 11th Assembly District. The Special Election Primary will be held on Tuesday, April 5, 2022.

Assembly District 49 – Endorsed Mike Fong

Due to the appointment of Assemblymember Ed Chau to the Los Angeles Superior Court, a Special Election has been scheduled for the 49th Assembly District. The Special Election Primary will be held on Tuesday, February 15, 2022.

Assembly District 17 (Primary) – No Consensus

Due to the appointment of Assembly Member David Chiu to the City Attorney of San Francisco, a Special Election has been scheduled for the 17th Assembly District. The Special Election Primary will be held on Tuesday, February 15, 2022

Assembly District 18 – Endorsed Mia Bonta

Due to the appointment of Assemblymember Rob Bonta as the Attorney General of the state of California, a Special Election has been scheduled for the 18th Assembly District. The Special Election General will be held Tuesday, August 31, 2021.

Assembly District 54 – No Consensus

Due to the election of Assembly Member Sydney Kamlager to the Senate, District 30, a Special Election has been scheduled for the 54th Assembly District. The Special Election Primary will be held on Tuesday, May 18, 2021.

Assembly District 79 – Endorsed Akilah Weber

Due to the nomination of Assemblymember Shirley Weber to the California Secretary of State, a Special Election has been scheduled for the 79th Assembly District. The Special Election Primary will be held on Tuesday, April 6, 2021.

Senate District 30 – Endorsed Sydney Kamlager

Due to the election of Senator Holly Mitchell to the Los Angeles County Board of Supervisors, District 2, a Special Election has been scheduled for the 30th Senate District. The Special Election Primary will be held on Tuesday, March 2, 2021.
